BACKGROUND

Canadian Association of Police Governance

The Canadian Association of Police Governance (CAPG) is the only national organization dedicated to excellence in police governance in Canada. Founded in 1989 with the goal to improve the effectiveness of civilian bodies that govern local police services, they have since grown to represent 80% of municipal police service oversight bodies throughout Canada.

For over 30 years, the CAPG has worked diligently to achieve the highest standards as the national voice of civilian oversight of municipal police. The CAPG works collaboratively and proactively with members and partners to enhance civilian governance of policing in Canada.

Canadian Association of Chiefs of Police

The Canadian Association of Chiefs of Police (CACP) is dedicated to the support and promotion of efficient law enforcement and to the protection and security of the people of Canada. Much of the work in pursuit of its new mandate, developed in 2013, "safety and security for all Canadians through innovative police leadership", is done through the activities and special projects of a number of committees and through active liaison with various levels of government and departmental ministries having legislative and executive responsibility in law and policing.

The Association is national in character. Its interests and concern have relevance to police at all levels including municipal, regional, provincial and federal. Many of the initiatives and the work of the Association and its committees through the year are reported on at the annual conference when recommendations are tendered and resolutions adopted. In many cases, these form the basis of the Association's ongoing work on behalf of the policing community and the society that it serves.

Attendance

The Canadian Association of Police Governance (CAPG) is holding its 35th Annual Conference in Halifax, Nova Scotia from August 8 - 11, 2024. All members of the Police Service Board received the conference information and were canvassed regarding their interest in attending. Chair S. Fakirani, Vice Chair Carr, and Senior Policy Advisor H. Sayah advised they wished to attend.

The Canadian Association of Chiefs of Police is also holding its annual summit in Halifax, Nova Scotia, immediately proceeding the annual conference of the CAPG. All members of the Police Service Board received the conference information and were canvassed regarding their interest in attending. Chair S. Fakirani, Member P. Henschel, and H. Sayah advised they wished to attend.

The Ottawa Police Service Board recognizes the importance of ongoing professional development and education for its members through its policies and through the training policy adopted in 2006 in response to a recommendation from the City's Auditor General. The Board also ensures that sufficient funds are included in its budget each year to support its commitment to ongoing education and to enable Board members to attend various learning opportunities throughout the year.

Sponsorship

Attached at Document 1 is a copy of the 2024 CAPG Conference Sponsorship Prospectus.

CONSULTATION

FINANCIAL IMPLICATIONS

The approximate cost of attending the CAPG conference is \$3,000 per person. Given the CACP summit is being held in the same city directly after the CAPG conference, the added cost of attending CACP is approximately an additional \$1,500 per person (total \$4,500 for both conferences). Funds have been allocated for this expense in the 2024 Staff Training and Development/Business Travel accounts. There are sufficient funds remaining in the Board's budget to cover this expenditure.

The Board is being asked to approve a \$1,000 sponsorship, consistent with previous years' sponsorship of this same event. The proposed \$1,000 sponsorship would be deducted from the Board's discretionary funds. Discretionary funds in the amount of \$121,500 have been included in the Board's 2024 budget.

Based on projected requests for discretionary funding in 2024, there are sufficient funds to cover this expenditure.
