APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION(S):

The Owner wants to construct a 6-storey residential building containing 109 dwelling units, shown as "Building 3" on plans filed with the Committee.

The Owner has also submitted Minor Variance Applications for proposed 9-storey mixed-use buildings on the properties at 1345 Hemlock Road (D08-02-23/A-00106, "Building 2") and 1375 Hemlock Road (D08-02-23/A-00107, "Building 1").

REQUESTED VARIANCES:

The Owner requires the Committee's authorization for a minor variance from the Zoning By-law to permit a building to be set back an additional 2 metres at and above the fifth

storey, whereas the By-law requires a building to be set back an additional 2 metres from the front and corner side lot lines at and above the fourth storey.

THE PROPERTY IS THE SUBJECT of a Site Plan Control application (D07-12-22-0127) under the *Planning Act*.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.
