APPLICANT'S PROPOSAL / PURPOSE OF THE APPLICATIONS:

The Owner wants to subdivide its property into three separate parcels of land to create two new lots for residential development.

At its hearing on February 6, 2024, The Committee adjourned the application to allow the applicant time to obtain an Environmental Impact Study. The applicant has submitted study and would like to proceed.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Committee's consent to sever the land. The property is shown as Parts 1 and 2 on a Draft 4R-Plan filed with the applications and the separate parcels will be as follows:

The land to be retained, shown on a sketch filed with the applications, will have a frontage of 50 metres, an irregular depth and a lot area of 16.36 hectares. This parcel is vacant and will be known as 897 William Mooney Road.

The application indicates the property is not subject to any other current applications under the *Planning Act*.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
