## City of Ottawa Arborist Report Template

This report template is part of an application requirement to remove a distinctive tree in the urban area of Ottawa as referenced in the Urban Tree Conservation By-law 2009-200. In order to minimize processing delays, the applicant should ensure that all required information is included in this application form.

The applicant (or their representative) must submit both the completed Application Form and Arborist Report Template as an attachment via email to [forestry@ottawa.ca](mailto:forestry@ottawa.ca). An invoice will be generated to the applicant (listed on Application Form) to pay a \$100 non-refundable application fee. Once the Application Form and Arborist report are received, a service request will be sent to a City of Ottawa Forestry Inspector for review.

If construction is planned for a site where distinctive trees (private trees that are 50 cm or greater in diameter) or municipally owned trees will be *retained*, they shall be protected in accordance with city tree by laws that require protective fencing around the critical root zones (a distance equal to 10 times the diameter of the trunk) of the trees.

Note: All owners of the distinctive tree must be in agreement with the tree removal. You are considered an owner of the tree if any part of the tree trunk (not including root flare) straddles your property.
