## 7.2 Chair of the Board of Health Verbal Report

As part of her verbal report, Chair Kitts, welcomed Board Members, Ottawa Public Health and City of Ottawa Employees and Members of the public. She recognized the importance of Mental Health Awareness week, taking place during the first week of May, reminded everyone of the resources available at Ottawa Public Health to promote good mental Health. Chair Kitts also discussed the Provincial budget, which was table in March 2024 and recognized local support from the province. Additionally, she talked about the new investments in housing in the City of Ottawa which was announced early in April by Premier Ford and Mayor Sutcliffe.

In closing, Chair Kitts provided an update on the Ministry of Health's 2023 initiative to support public health units to pursue mergers with other health units. She reminded attendees that the Ottawa Board of Health's desire is to maintain the existing governance, geographic boundaries, and service structure that currently exists within the City of Ottawa, noting that this scenario provides the best net benefits to the residents of Ottawa.
