The Owner wants to subdivide the property into two separate parcels of land to create two new lots for the construction of a two-storey semi-detached dwelling. The existing detached dwelling will be demolished.

Approval of these applications will have the effect of creating two separate parcels of land. The proposed development will not be in conformity with the requirements of the Zoning By-law and therefore minor variance applications (D08-02-23/A-001349 & D08-02-23/A-00150) have been filed and will be heard concurrently with these applications.

REQUESTED VARIANCES:

The Owner requires the Committee's authorization for the minor variances from the Zoning By-law as follows:

A-00149: 469 Edgeworth, Part 1 on 4R-Plan, proposed semi-detached dwelling:

- a) To permit a reduced lot width of 7.62 metres, whereas the By-law requires a minimum lot width of 9 metres.
- b) To permit a reduced lot area of 231.9 square metres, whereas the By-law requires a minimum lot area of 270 square metres
- c) To permit a front-facing attached garage, whereas the By-law states that a front-facing garage is not permitted as per the outcome of the Streetscape Character Analysis.

A-00150: 471 Edgeworth, Part 2 on 4R-Plan, proposed semi-detached dwelling:

- d) To permit a reduced lot width of 7.62 metres, whereas the By-law requires a minimum lot width of 9 metres.
- e) To permit a reduced lot area of 231.9 square metres, whereas the By-law requires a minimum lot area of 270 square metres
- f) To permit a front-facing attached garage, whereas the By-law states that a front-facing garage is not permitted as per the outcome of the Streetscape Character Analysis.
