### APPLICANTS PROPOSAL / PURPOSE OF THE APPLICATION:

On December 8, 2021, the Committee conditionally approved a Consent Application to subdivide the property into two lots. The conditions were not fulfilled within the statutory timelines and the approval has lapsed.

The Owner is now re-applying to to subdivide their property into two separate parcels of land to create one new lot for future residential development.

**CONSENT IS REQUIRED FOR THE FOLLOWING:**

The Owner requires the Committee's consent to sever.

The severed land is shown as Part 1 on Plan 4R-35169 filed with the application, and will have a frontage of 56.9 metres, an irregular depth and an area of 0.8 hectares. This parcel is currently vacant and will be known municipally as 1380 Corkery Road.

The retained land is shown as Part 8 on a sketch filed with the application, and will have a frontage of 95.39 metres, an irregular depth and an area of 9.8 hectares. This parcel contains the existing residential dwelling, garage and outbuilding and is known municipally as 1390 Corkery Road.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
