APPLICANT'S PROPOSAL AND PURPOSE OF THE APPLICATION(S):

The Owner wants to construct a two-storey addition and front facing garage on the east side of the existing detached dwelling, as shown on plans filed with the Committee.

The Committee of Adjustment adjourned this application from its scheduled hearing on August 16 to allow the Applicant to review its plans and the requested variances.

REQUESTED VARIANCES:

The Owner/Applicant requires the Committee's authorization for minor variances from the Zoning By-law as follows:

- a) To permit a reduced total interior side yard of 1.51 metres, with the south side yard being 0.21 metres and the north side yard side being 1.30 metres, whereas the By-law requires a total interior side yard of 1.8 metres with no side yard less than 0.6 metres.
- b) To permit an increased front yard setback of 5.27 metres, whereas the By-law permits a maximum front yard setback of 3.75 metres.
- c) To permit a front facing attached garage, whereas the By-law does not permit a front facing attached garage based on the conclusions of a streetscape character analysis.

IF YOU DO NOT PARTICIPATE in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

IF YOU WANT TO BE NOTIFIED OF THE DECISION following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

COMMITTEE OF ADJUSTMENT

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
