**APPLICANT'S PROPOSAL / PURPOSE OF THE APPLICATIONS:**

At its hearings in January 2023, the Committee refused a consent and minor variance application. The decisions of the Committee of Adjustment were appealed to the Ontario Land Tribunal and granted.

The Owner now wants to establish easements to accommodate shared driveway, as shown on plans filed with the Committee.

**CONSENT IS REQUIRED FOR THE FOLLOWING:**

The Owner requires the Committee's consent to grant easements/ right of ways. The property is shown as Parts 1-5 on a Draft 4R-Plan filed with the applications and the requested easements are as follows:

- Over part 2 in favour of part 3, 4 & 5 for vehicular access.
- Over part 3 in favour of parts 1 & 2 for vehicular access.

**REQUESTED VARIANCES:****A-00238-124 Granton Avenue**

The Owner/Applicant requires the Committee's authorization for a minor variance from the Zoning By-law to permit a driveway to be located between the front wall of a building and the street whereas the By-law does not permit a part of the driveway to be located between the front wall and the street.

**THE APPLICATION** also indicates that the Property is not the subject of any other current application under the *Planning Act*.

**IF YOU DO NOT PARTICIPATE** in the hearing, it may proceed in your absence, and you will not receive any further notice of the proceedings.

**IF YOU WANT TO BE NOTIFIED OF THE DECISION** following the hearing, and of any subsequent appeal to the Ontario Land Tribunal, submit a written request to the Committee.

The Committee of Adjustment is the City of Ottawa's quasi-judicial tribunal created under the Ontario *Planning Act*. Each year, it holds hearings on hundreds of applications under the *Planning Act* in accordance with the Ontario *Statutory Powers Procedure Act*, including consents to sever land and minor variances from the zoning requirements.
