APPLICANTS' PROPOSAL / PURPOSE OF THE APPLICATIONS:

The Applicants wants to subdivide their property into two separate parcels of land to create two new lots for residential development, as shown on the plans filed with the Committee. The existing dwelling will be demolished.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Applicants require the Committee's consent to sever land.

The severed land is shown as Parts 1 and 2 on the Draft 4R-Plan. This parcel will have a frontage of 14.45 metres, an irregular depth, and an area of 720.5 square metres. This lot will be known municipally as 265 Marilyn Avenue.

The retained land is shown as Parts 3 & 4 on said plan and will have a frontage of 14.45 square metres, an irregular depth, and an area of 670 square metres. This lot will be known municipally as 267 Marilyn Avenue.

The application indicates that Parts 2 and 4 are subject to an existing easement as set out in Instrument OT6888.

Approval of this application will have the effect of creating separate parcels of land that will not be in conformity with the requirements of the Zoning By-law and therefore, minor variance applications (File Nos. D08-02-24/A-00177 & D08-02-24/A-00178) have been filed and will be heard concurrently with this application.

REQUESTED VARIANCES:

The Applicants require the Committee's authorization for minor variances from the Zoning By-law as follows:

A-00178: 265 Marilyn Avenue, Parts 1 & 2 on 4R-Draft Plan.

a) To permit a reduced lot width of 14.45 metres, whereas the By-law requires a minimum lot width of 18 metres.

A-00177: 267 Marilyn Avenue, Parts 3 & 4 on 4R-Draft Plan:

b) To permit a reduced lot width of 14.45 metres, whereas the By-law requires a minimum lot width of 18 metres.

The property is not the subject of any other current application under the *Planning Act*.
