# 5.1 <u>Wetland Omnibus Official Plan Amendment and Zoning By-law</u> <u>Amendment</u>

- Janet Stavinga, Friends of Stittsville Wetlands spoke to the importance of protecting our wetlands and provided a summary of the issues with the Staff report, and recommendations for the Committee to consider outlining four themes. A copy of the PowerPoint presentation is held on file with the Office of the City Clerk.
- Tony Morris, Ontario Nature spoke to wanting to ensure wetlands are protected. Loss of Provincially significant wetland status on these wetlands is a disturbing trend. Steps must be taken to protect remaining wetlands for biodiversity and flood mitigation.
- Regent Pomerleau noted he had questions related to his property and advised he would speak to staff offline.
