THAT, as part of the 3-item limit roll-out, staff be directed to work with operators and solid waste inspectors to use their discretion for residents whose bins have historically been collected without issue but are somewhat over the 140 litre volumetric limit so long as the bins contain no more than 140 litres of waste, do not exceed weight limits, and continue to meet handle and removable lid requirements.

  - 10.1 Solid Waste Services By-Law Update

Moved by Councillor D. Brown

WHEREAS in 2023 City Council approved the implementation of a 3item limit garbage collection limit which was introduced on September 30, 2024; and

WHEREAS agricultural operators who receive curbside collection have expressed concerns about how the 3-item limit and seasonal agricultural exemption are insufficient for disposal of unavoidable farm waste; and

WHEREAS additional work is required to develop an approach to solid waste management that fully considers the unique challenges of waste collection in rural Ottawa, including greater exposure to animals and the elements, extremely long laneways, and out-ofseason unavoidable farm waste.

THEREFORE BE IT RESOLVED THAT staff in Solid Waste Services be directed to work with the Rural Affairs Office to develop a rural solid waste strategy that contemplates separate by-law provisions for rural Ottawa that encourage increased waste diversion while accommodating the unique needs of rural residents and agricultural operators; and

BE IT FURTHER RESOLVED THAT, until such time as a rural solid waste strategy is implemented, staff be directed to work with operators to ensure that the provisions respecting Garbage Limits approved by Council in 2023 do not apply to unavoidable farm waste, which includes items such as feed bags, bale wrap and twine, disposed of at residential dwellings with farms that receive curbside collection, so long as these properties are also participating in waste diversion efforts through the use of green bins, black bins, and blue bins.

NOTE: Following the adoption of Motion N<sup>o</sup> OCC 2024-45-02 at the City Council meeting of 30 October 2024, Councillor D. Brown withdrew the above-noted Notice of Motion pursuant to Subsection 60(6) of the *Procedure By-law.*

## 11.1 ECCC-2024-02 - Wood burning fireplaces

Submitted by Councillor T. Kavanagh:

Recent Health Canada estimates indicate that home firewood burning is a significant contributor to air pollution-related deaths in Canada. It also leads to increased health issues, including acute respiratory problems, asthma symptoms, higher rates of hospital admissions, and elevated bronchitis cases in children.

Could staff please answer the following questions:

- 1. Does the city monitor the impacts of woodburning fireplaces or stoves on air quality in Ottawa?
- 2. Do other municipalities in Canada monitor the impact of woodburning fireplaces or stoves on air quality?
- 3. What kind of regulations does the city currently have for woodburning fireplaces or stoves?
- 4. Do these regulations include requirements wood-burning devices to be either EPA-certified or compliant with Canadian Standard CSA/B415.1-10?
- 5. What other municipalities in Canada, if any, have regulations regarding woodburning fireplaces and stoves?
- 6. Can staff provide a brief overview of these regulations?
