Document 1 – Proposed Development Charge Amending By-law

BY-LAW NO. 2024 -

A by-law of the City of Ottawa to amend By-law 2024-218, the Development Charges By-law, 2024.

WHEREAS the Council of the City of Ottawa enacted By-law 2024-218 on May 15, 2024;

AND WHEREAS the *Development Charges Act*, subsection 19(1.2) permits the enactment, on or before December 6, 2024, of a development charges amending by-law to permit the imposition of a development charges in respect of Development Related studies without sections 10 to 18 of the *Development Charges Act* applying;

THEREFORE the Council of the City of Ottawa enacts as follows:

- 1. By-law 2024-218, subsection 3(2) is amended by adding thereto the following clause:
 - (i.1) Development Related Studies;
- 2. By-law 2024-218, section 17 is amended by adding thereto the following subsection:
 - (11.1) The development charges imposed by this by-law for Development Related Studies shall be paid into the Development Related Studies Development Charges Reserve Fund and all development charges imposed by the City by any development charges by-law for Development Related Studies purposes shall be deemed to be in respect of a single service.
- 3. By-law 2024-218, section 18, as amended is further amended by adding thereto the follow subsection:
 - (1.4) The Development Related Studies development charge in Schedules "B" and "C", as added through the Development Charges Bylaw Amendment (No. 3), 2024 shall not be indexed pursuant to subsection (1.1) on April 1, 2025 but shall be indexed pursuant to subsection (1.2) on each April 1 thereafter.
- 4. Each of the tables for Inside the Greenbelt, Outside the Greenbelt, Rural Serviced and Rural Unserviced on Schedule "B", as amended, of By-law 2024-218, is further amended by adding thereto, after the line for Libraries, the following line:
