Document 4 - Warranted Traffic Signal Locations Status Update

There is currently a total of 36 locations in Ottawa that are warranted for the installation of traffic signals. Warranted locations are listed in Table 1 below by Ward and area designations have been identified to help identify those in urban/suburban and rural settings. Once a location meets the minimum warrants for traffic signals, it is added to the New Traffic Control Devices (NTCD) Program list of warranted traffic signals. The list is prioritized based on several factors including level of warrant criteria met, collision rates, Annual Average Daily Traffic (AADT) volumes, roadway speed and environment. The ranking of each warranted location can fluctuate over time as new traffic data is collected and reassessed and as new locations become warranted. The priority list includes all warranted traffic signal locations, whether in urban, suburban, or rural areas.

Staff have estimated that a high-level amount of approximately \$126 million in 2024 dollars is required to implement traffic signals or roundabouts at all warranted locations in Ottawa. The cost estimate breakdown by area designation is:

- \$52.5 million in urban/suburban areas;
- \$73.5 million in rural areas.
