RE: PROPOSED ALTERATION OF ST BRIGID'S CENTRE FOR THE ARTS 310 ST PATRICK ST OTTAWA, ON: APPLICATION UNDER PART IV OF THE ONTARIO HERITAGE ACT

On behalf of St Brigid's Centre for the Arts, we are pleased to submit this Application to Alter under Part IV of the Ontario Heritage Act for review by Ottawa City Council. The application is to seek approval to remove the ground floor pews in order to permit the use of the ground floor as a flexible multipurpose events space.

Although this intervention would somewhat reduce the heritage value of St Brigid's interior by the removal of one of its heritage attributes (a negative impact), the alteration would have the benefit of creating a space that generates revenue that could be applied to conserving the building's primary exterior and interior heritage character defining elements— whose conditions have steadily deteriorated—decreasing the unintended risk of losing the integrity of this *historic place*" (a very positive impact).

As requested in your memo dated September 5,2024 during the preconsultation process, the following information is provided in this submission in support of the application:

- 1. A completed Heritage Permit application form;
- 2. Plans showing the location of the affected pews
- 3. Photos of the pews
- 4. Description of work, including a reason for the proposed removal/alteration and how this has the potential to impact the heritage attributes of the property
- 5. Salvage plan for the pews

PART 1: Introduction

1.Introduction

St. Brigid's Church at 310 St. Patrick Street was erected in 1889-1890 to serve as the home of anglophone (mainly Irish) Catholics, a community originally part of the predominantly francophone parish centred on the Notre-Dame Cathedral Basilica at 385 Sussex Drive.

In 1981, St Brigid's Church was designated by the City of Ottawa under Part IV of the Ontario Heritage Act. The building, an Ottawa landmark, is a massive limestone structure designed by architect J.K. Bowes in an eclectic Victorian style, with basic Gothic Revival form and extensive Renaissance Baroque Revival detail. The designation includes interior features such as vaulted ceiling, polychromed interiors, wall paintings, altar, iron columns, carved woodwork, stained glass, organ, floors and pews. (See Appendix B: Statement of Cultural Heritage Value).

In 1985, and 1990 grants were provided to the Roman Catholic Episcopal Corporation to carry out certain conservation actions (steeple repairs and restoration of hidden interior wall paintings) in exchange for a heritage easement on the property (See Appendices F,G, and H).

In 2006, due to a shrinking congregation and the high cost of continued repairs, the Archdiocese announced the closure and de-consecration of St. Brigid's. The parishioners objected vehemently to the closure and took the Archdiocese to court. Their appeal was unsuccessful.

In 2007 the Archdiocese sold property to a group of individual investors who formed St Brigid's Centre for the Arts with the objective of saving the historic structure and providing a centre for Irish-Canadian culture.

For the last 17 years the building has operated as a venue for public and private events (art exhibits, plays, concerts, corporate gatherings) actively supported by significant owner investments in the aging building systems, the adaptive re-use of the basement (Kildare Room, Brigid's Well Pub, commercial kitchen and ample washrooms). A temporary, demountable stage has been installed in the ground floor apse (south end) to facilitate some active use of the main worship space.

In 2022, St Brigid's Centre for the Arts agreed to sell the property to The United People of Canada (TUPOC) for its "embassy". The tragic story of this failed initiative (at the time of the Freedom Convoy demonstrations in downtown Ottawa) was the subject of national media coverage and involved appeals to the Ontario Superior Court of Justice before being resolved.

In the absence of significant municipal, Ontario or federal heritage grant assistance, and notwithstanding the owners' personal funding contributions, the limited revenue from rental activities has not permitted the investments necessary to reduce the St Brigid's Centre for the Arts growing heritage infrastructure deficit.

In 2023, in order to understand the magnitude of the heritage infrastructure deficit, the City of Ottawa, at the request of St Brigid's Centre for the Arts, engaged consultants to prepare a Building Condition Report. The report, by RMA + SH Architects with input from John Cooke & Assoc Engineers, examined the condition of the building's heritage character defining elements. The report included an order of magnitude (Class E) cost estimate for a 10-year action plan to address the urgent, short term, medium term and long term actions needed to conserve the building's deteriorating heritage infrastructure. The estimate, in the order of \$18.2 million excluded soft costs and the renewal of non-heritage but essential features.

PART 2: From Worship Space to Events Space

2. From Worship Space to Events Space

To enable some investment in the conservation of St Brigid's deteriorating heritage infrastructure, the adaptive re-use of the ground floor of St Brigid's Centre for the Arts offers an opportunity to somewhat increase revenue by meeting the market demand for an iconic, distinctive, flexible, usable space for social events, weddings exhibitions, performances, conferences and corporate gatherings.

The St Brigid's team has concluded that the simple removal of the existing fixed pews and the levelling of the (two-level) hardwood floor can transform the former worship space into an appealing barrier-free venue that meets the functional and aesthetic criteria for increased usage and revenue generation. The repurposed St Brigid's flexible events space is estimated to have the capacity to accommodate up to 300 to 500 persons depending on the format of the event (eg: performances, cabaret events, weddings and banquets). It is noted that the former St Brigid's Church worship space had a capacity of 538 persons (fixed pew seating).

A recent local example of a successful transformation from worship to flexible event space has been realized at the former All Saints Ottawa Church, (now All Saints Events Space) 330 Laurier Ave East associated with the Working Title restaurant.




Figure 7: St Brigid's Centre for the Arts Ground Floor Plan showing location of fixed pews to be removed (outlined in red lines); pews removed in 2007 (outlined in light red dotted lines) and location of temporary demountable raised stage (outlined in light blue dotted lines)




Figure 8: St Brigid's Centre for the Arts Interior Elevation showing location of fixed pews to be removed (outlined in red lines) and pews removed in 2007 (outlined in light red dotted lines)



PART 3: Existing Conditions

Part 3: Existing Conditions

Field inspections have revealed that the existing pews are anchored to 2 inch high platforms composed of hardwood flooring laid in a north-south direction stepping down to the Worship space's walking areas whose hardwood flooring is laid diagonally (see Figure 9). An exploratory opening demonstrates the construction details of the raised hardwood platforms. (see Figure 10).

PART 4: Description of the Work

4. Description of the Work

The scope of the work for which the heritage permit is submitted will include the following interventions undertaken by qualified trades experienced in wood conservation and finished carpentry. The work will be recorded and monitored by a heritage consultant.

Intervention #1: Dismantle and remove the fixed pews from the areas outlined in red (Figure 7 above).

Intervention#2: Label, move and store the pews safely off site.





Figure 11: St Brigid's Centre for the Arts Ground Floor Plan showing areas of hardwood flooring to repaired and restored (outlined in red) and areas of new hardwood flooring (in grey tone) installed to match the level of the restored flooring.

Intervention #3: Evaluate the conditions, repair, sand and refinish the raised hardwood flooring in the areas outlined in red (Figure 11 below.)

Intervention #4: Install new hardwood flooring in a diagonal pattern on wood sleepers in the areas outlined in grey to create a barrier free level floor matching the level of the raised hardwood flooring (Figure 11 below).

PART 5: Salvage Plan for Pews

5. Salvage Plan for Pews

The St Brigid's Centre of the Arts has developed a 3 part Salvage Plan for the wood pews to be removed from the ground floor worship space. These are:

1. Prepare an inventory and documented record of the pews.




Figure 12: As found drawing of pews (2007)




Figure 13: St Brigid's Centre for the Arts basement plan showing proposed relocation of selected worship space pews

2.Relocate and conserve a specific number of pews to the Kildare Room and Brigid's Well Pub in the basement of St Brigid's Centre for the Arts as functioning exhibits in the locations shown in Figure 13 below.

3. Offer (gift or sell) surplus pews (in order of precedence) to faith congregations, The Canadian Museum of History, and the public (possibly through charitable non-profit organizations if feasible).

Barry Padolsky, B. Arch., M. Sc. (Urban Design), OAA, FRAIC, RCA, CAHP is a member of the Ontario Association of Architects (1965); the Royal Architectural Institute of Canada, (1965); a Fellow, Royal Architectural Institute of Canada, (1987); the Canadian Association of Heritage Professionals (2003); and the Royal Canadian Academy of Arts (2006). He has been recognized with 43 national and civic architectural and urban design awards, including 29 for heritage conservation. He was a member of the City of Ottawa Built Heritage sub-committee advising Ottawa City Council on heritage matters (2013-2023) and was honoured with the Order of Ottawa (2021). In 2023, he was appointed to serve on the NCC's Advisory Committee on Planning, Design and Realty.

Padolsky has served as the conservation architect and heritage consultant to the St. Brigid's Centre for the Arts since the property was acquired from the Roman Catholic Archdiocese in 2007.

APPENDIX B

BY-LAW 129-81

Statement of Cultural Heritage Value or Interest

St. Brigid's Church at 314 St. Patrick Street is recommended for designation as being of architectural interest. Erected in 1889-1890, this massive limestone structure with pitched roof and two towers of different heights was designed by J.K. Bowes in eclectic Victorian style, with basic Gothic Revival form and extensive Renaissance Baroque Revival detail.

It has historically served as a parish church for the Irish Catholic working class residents of Lowertown. In its overall exterior appearance, the church is a significant reminder of their contribution to the growth of Bytown and Ottawa.

The interior of St. Brigid's Church is significant for its vaulted ceiling, polychromed interiors, carved woodwork, and stained glass. This designation includes floors, walls, ceiling, windows, and attached fixtures of all interior spaces including the nave and alter area with reredos, side aisle and transepts, the entrance area and organ gallery above. Of particular note are the polychromed interior painting schemes found beneath the existing layer of white paint. Physical investigation of historical photographs have discovered a wide variety of trompe-l'oeil painting techniques including marbelizing, stencil work and figurative murals employed on walls, iron columns, canvas panels, and vaulted ceilings. All decorative wood carving, including but not exclusive to, wainscoting, pews, confessionals, altar and organ are also to be preserved. This designation does not make reference to the basement or areas in the upper floors and towers.

Hi Ashley,

Thanks for taking my call today. And thank you for forwarding the documents associated with the designation of St Brigid's under Part IV of the OHA and the OHT easement.

As part of my long-established role of as heritage advisor to the owners, I have been specifically engaged by St Brigid's to prepare applications to the City of Ottawa and the OHT (as required) for the following immediate priority #1 short term interventions to St Brigid's upper level (the former worship space):

- 1. Remove and conserve the existing wood pews
- 2. Relocate a select number of pews to the St Brigid's basement activity spaces (St Brigid's Well and the Kildare Venue); find appropriate off-site "homes" for the remainder of the pews.
- 3. Restore the hardwood floors in the zones formerly occupied by the pews (level 0.00 mm)
- 4. Add hardwood flooring in the aisle space zones, now at a lower level (minus 40mm approx) with new hardwood flooring to raise the level to 0.00mm. This intervention is needed to make the former worship space level and void of tripping hazards.

As you know, these interventions are specifically designed to make the former worship space immediately usable for events that can increase the revenue needed for urgent building repairs and halt the continued deterioration of the heritage character defining elements of this heritage landmark.

Please consult with your colleagues and advise me on the minimum submission requirements for an application to the City under the OHA if required. I hope that the requirements will not be too onerous since there are not the resources available for this task. Please also advise whether the application can be reviewed at a delegated staff level (or whether it requires Council approval). I would hope that an application form and a clear simply illustrated letter would be acceptable.

I would also appreciate advice on the application process to be followed to obtain OHT approval of these interventions

The St Brigid's team would like to proceed quickly in order to make the "flexible" former worship space available to potential users as soon as possible.

Lesley and I have had a chance to discuss the pew removal, and we feel that this is beyond the authority delegated to staff, so will ask for a full permit to committee and Council. That being said, we think that the fee for a staff level permit (\$286) is most appropriate for this scale of project.

While we have no concern with this, and will expedite the process as quickly as possible, there are a few things we will require from you in order to proceed:

- 1. Completed application form (<u>Application for permit under the ontario heritage act-Application Form (ottawa.ca)</u>) Please sign under Part "A" on the third page.
- 2. Application payment of \$286 (to be completed after submitting the application form)
- 3. Description of work, including a reason for the proposed removal/alteration and how this has the potential to impact the heritage attributes of the property
- 4. Site plan or Sketch showing the affected pews
- 5. Photos of the pews
- 6. Salvage plan for the pews

Since the interior is designated under Part IV of the *Ontario Heritage Act*, we need to follow the new(ish) process for processing Part IV applications. This requires a few extra items (already listed above), and also an application form that is signed by a Commissioner of Oath. The City of Ottawa provides this service free of charge for heritage permit applications. More information can be found on our website: Commissioner of Oath I City of Ottawa
