SUBJECT: APPOINTMENT OF SPECIAL CONSTABLES – CARLETON UNIVERSITY

**OBJET: NOMINATION DES AGENTS SPÉCIAUX – UNIVERSITE CARLETON** 

### **REPORT RECOMMENDATIONS**

That the Ottawa Police Service Board approve the appointment of four (4) Carleton University (Campus Safety Services) employees listed in Appendix 1 as Special Constables for Carleton University pursuant to Section 92 of the Community Safety and Policing Act (CSPA).

## **RECOMMANDATIONS DU RAPPORT**

Que la Commission de service de police d'Ottawa approuve la nomination de quatre (4) employés de l'Université Carleton (Services de sécurité sur le campus) énumérés à l'annexe 1 à titre d'agents spéciaux pour l'Université Carleton, conformément à l'article 92 de la Loi sur la sécurité communautaire et le services policiers (LCSP).

## BACKGROUND

Section 92 of the Community Safety and Policing Act (CSPA) allows the Ottawa Police Service Board (the Board) to appoint Carleton University (Campus Safety Services) employees as Special Constables when Special Constable authorities are required to carry out their duties. Carleton University is authorized to employ Special Constables under the CSPA, effective November 26<sup>th</sup>, 2024 (please refer to supporting documentation – Appendix 2). The four (4) appointees will be employed by Carleton University (Campus Safety Services).

The appointments provide these members the authorities they require to carry out their assigned duties as Special Constables for Carleton University (Campus Safety Services), to include police officer powers as contained in Section 39 and Section 42 of the "Agreement Regarding Special Constables" between the Board, Carleton University, and the Ottawa Police Service (OPS) dated October 18th, 2024. The appointment does not permit the carriage of a firearm.

These individuals will work as Special Constables for a five-year period, or until the appointees are no longer employed by Carleton University (Campus Safety Services) or until they cease to perform the duties outlined above.

The employees named below have met the training and appointment requirements as stipulated under the CSPA Ontario (Regulation 87/24 and Section 92).

In accordance with CSPA Ontario Regulation 396/23 and as agreed between the Board, Carleton University, and the Ottawa Police Service in the "Agreement Regarding Special Constables," Carleton University Special Constables have peace officer and/or police powers on or in-relation to the properties, facilities, and assets under the control of Carleton University under the following legislation:

Cannabis Control Act;

Courts of Justice Act;

Liquor Licence and Control Act, 2019;

Mental Health Act;

Provincial Offences Act;

Safe Streets Act, 1999;

Smoke-Free Ontario Act;

Trespass to Property Act;

Youth Criminal Justice Act (Canada);

Courts of Justice Act;

Criminal Code, R.S.C. 1985, c. C-46, sections 129, 130, 139, 140, 145(1), 145(3), 145(2), 145(5), 145, 173, 175, 180(1), 248, 264.1, 266, 267(a), 270, 334(a)(b), 354(1), 362(2)(b), 368, 372 (1), 372(3), 380(1)(b), 393(3), 403, 430(4), 430(3), 437, 733.1, 811, 495;

Controlled Drugs and Substances Act, S.C. 1996, c.19, sections 4(3), 4(4), 4(5), 4(6); and 5(1), and the Child, Youth and Family Services Act, 2017, S.O. 2017, c.14, Sched. 1, as amended, sections 83(4), 136(5), 172(1)(2).

In accordance with CSPA Ontario Regulation 396/23 and as agreed between the Board, Carleton University, and the Ottawa Police Service in the "Agreement Regarding Special Constables," Carleton University Special Constables are permitted to possess and use the following use of force weapons in relation to their duties:

- A baton, handcuffs, and oleoresin capsicum spray/foam.

Upon termination of employment, Carleton University (Campus Safety Services) will advise the Board of the conclusion of the appointment.

## DISCUSSION

The special constable appointment application forms have been provided to the Board for the Chair's signature.

## CONSULTATION

Brian Billings, Executive Director – Campus Safety Services at Carleton University has been consulted with respect to the appointment of these applications for Special Constables at Carleton University and has provided the required supporting documentation from the employer (Carleton University) for these special constable appointments.
