Excerpt from Letter: Two months ago I had to take Jack to CHEO in the middle of the night. Jack has several medical conditions, one of which is his body's inability to fight illness or heal from injury. We have a team of specialists and are known by name in the emergency room. On October 22nd, Jack had another adrenal crisis so after hours of treating him at home, we had to give him a steroid injection at home then take him to emerg. When I got there, there was an officer dealing with another situation. Jack LOVES police and wants to be a police officer when he's older. He was so sick and could barley walk but his face lit up when he saw. "Mom look! It's a real life police, can I say hi?" I asked the officer if he had a minute and explained how my 3 year old is obsessed and wanted to say hi. It's was after midnight and this man clearly had a lot going on but he did not hesitate. He crouched down to Jack's level and talked to him. He told us when he was little he was in the hospital a lot to and told Jack he was so brave and strong. Not only was that all Jack talked about that night but 2 months later he still brings it up. He tells everyone about that officer and how he is brave and strong and will be just like him one day. That officer had such a massive impact on my son that night. Jack's health is a rollercoaster and the worst is still to come but seeing him still light up about a time that's usually very traumatic makes me so happy.

So from the bottom of my heart, thank you to the officer that took the time to light up the dark with my 3 year old. They say never to meet your heros but Jack did and he did not disappoint!

There is a great need for mental health support and I hope to see this unit expand to reflect this need. Together we can work to support people with mental illness in a positive way. Way to go Dodd!! I have had a few months now to recover from what was undoubtedly one of the worst nights of my life, and I want to thank those three officers for being so cavalier and kind in their treatment of me.
