#### **BACKGROUND**

#### **DISCUSSION**

I had the pleasure to attend the North American forum of the International Association of Public Transit (UITP) from June 23-25, 2024 in Vancouver, British Columbia. I did so in my capacity as a Transit Committee Member of OC Transpo.

# What is the Union Internationale des Transports Publics

UITP (Union Internationale des Transports Publics) is the International Association of Public Transport and a passionate champion of sustainable urban mobility. Established in 1885, it is the only worldwide network to bring together all public transport stakeholders and all sustainable transport modes.

Across the globe and every day, people rely on public transport to bring them to school, to work, to sports clubs and cafés. In using public transport millions travel more sustainably, safer and actively while bringing economic benefit to their community. UITP supports the entire sector to ultimately guarantee that public transport and its workers continue to bring cities to life.

# **North American Forum**

The International Association of Public Transit (UITP) hosted their annual North America Forum in June 2024 in Vancouver, British Columbia. I attended the Forum.

The UITP North America Forum is an annual conference aimed to offer the North America region UITP's worldwide resources for global connectivity and knowledge, bringing together the most current information and developments for our urban transit industry. The 7<sup>th</sup> Edition of UITP North America Forum in Vancouver was an opportunity to bring members from around the world.

TransLink, proud local host, is the transit authority responsible for the regional transportation network of Metro Vancouver, including public transport, major roads and bridges.

The Forum was multimodal including bus electrification, rail automation and on-demand mobility, and also featured several in-person networking opportunities, enabling instant connectivity between industry suppliers and transit operators. UITP's global presence,

institutional knowledge, network via its members enabled the conference to bring together experts with the most current and relevant information.

"For this edition of the North America Forum, UITP and TransLink have joined forces to encourage the debate around the latest innovative developments taking place in urban transit... Progress is made through collaboration... If we are able to continue developing the sector, then we can grow its image, attract more passengers and employees, and in turn, we can make public transit the logical, obvious, popular choice for city movement."

# **Key Themes from the Forum**

#### Innovation

Innovation is necessary to ensure that we can continually improve services and become more efficient (that helps solve some of our sector's other challenges too). From bus rapid transit (BRT), to the digital transformation of rail, and open-loop payment, the North America Forum showcased how innovation is pushing public transport forward.

- **BRT** is booming. BRT projects make up 40 of the 61 public transport projects earmarked for funding by the US Federal Transit Administration.
- Digitalization is changing ticketing. Namely, open-loop payments are a
  potential way forward, with open-loop and closed-loop ticketing likely to coexist.
- **New legislation aids transit.** For example, in British Columbia, Canada, new laws encourage building communities near transit, services, and amenities.
- Intermodality. Shared mobility, from shared bikes to micromobility, is helping develop an intermodal system, and many transit agencies are integrating these modes.
- Zero-emission transit. While it's our shared goal, how we get there differs on
  the local contexts. The transition needs the right workforce, equipment, and
  infrastructure. During a key panel session, experts from TransLink, EMT Madrid,
  SFMTA, and Hitachi Energy shared best practices from previous zero emission
  deployments.

But making innovation happen means funding innovation. For that to be done successfully, we need a collaborative approach.

# **Funding and Collaboration**

During the session 'Investing in Tomorrow: What are the Funding and Financing Challenges?', moderated by UITP's Andrea Soehnchen, experts outlined the basis for action to address the challenge of funding innovation.

Among the solutions highlighted was public-private-partnerships (PPPs), which are used to transfer risk and provides for innovation and evolution in the market. In the US, their use "depends on each state" and their specific legislation regarding private investment in public infrastructure. On the other hand, Canada has long been a prolific user of PPPs. But today there is a shift towards co-development that involve a more collaborative approach, and this is happening in the US too.

Daniel Farina, the General Manager of CDPQ Infra, noted that the company aims to "partner with local authorities in order to provide expertise and funding to deliver large-scale infrastructure projects". It's like this that CDPQ Infra has helped deliver the Réseau express métropolitain (REM).

#### Increase Demand

Increasing demand, in some places booming even, is bringing passengers to public transport from the lows of 2020. At the end of 2023, ridership data showed that across the United States passenger volumes reached 79% of pre-pandemic levels (as noted in an <u>APTA Public Transportation Ridership Update</u>), owing to a huge 16% annual increase in trips. But there is still more to go.

For their part, VIA Rail Canada saw an increase of 25% in passenger numbers in 2023 compared to 2022. At the same time, funding remains an issue, especially the instability of budgets. On that note, Mario Peloquin (President and CEO of Via Rail Canada) sees the increasing passenger numbers as an opportunity and that this should be built on by boosting service frequency.

#### Recruitment and Retention

Attracting and retaining talent is a challenge everywhere and it is affecting the quality of services. Today, 96% of American transit agencies are experiencing workforce shortages. With this, solutions are being brought forward with urgency.

In a discussion with Dallas Area Rapid Transit (DART) President and CEO Nadine Lee, it was noted that DART has approved a "Strategic Plan to Guide Future Priorities and Innovation", with an empowered workforce as one of the key priorities. The

development of that plan involved input from employees, passengers, city leaders, and regional partners.
