Excerpt from Letter: Colleagues / Supervisor(s) of Constable Ahmed Abou-Arab, I hope this email finds you well. I am writing to formally commend Constable Ahmed Abou-Arab for his exceptional service during an incident on January 3rd, when a fire occurred around 4:30 a.m. at the Foster Farm building located at 1065 Ramsey Crescent, near our workplace. Constable Abou-Arab went above and beyond to assist the community in need. His professionalism, calm demeanor which was both comforting and reassuring greatly contributed to helping so many people. Many families, including toddlers and newborns, were stranded outside in -20°C temperatures with little clothing or footwear, devastated and in shock. Due to frequent false alarms in the building, many residents initially stayed inside, only realizing too late that this was a real fire. By the time they attempted to evacuate, several floors were already filled with thick black smoke, making escape extremely challenging and dangerous. Recognizing the urgency of the situation, myself, and another colleague opened the Ron Kolbus Clubhouse as an emergency shelter to help the families in our community. Even after OC Transpo buses arrived, they quickly filled up, leaving many still in need of a safe, warm space. By 5:45 a.m., nearly 100 people had gathered inside our building.

Constable Abou-Arab remained with us in the Ron Kolbus Clubhouse throughout the morning, offering calm reassurance and frequent updates about when people might return home. Understandably, many people were frustrated due to the early hour and the uncertainty about when they could return to their apartments. Despite this, Constable Abou-Arab was excellent in helping us manage the chaos and he was focused on keeping everyone as calm as possible. His true empathy and understanding of everyone's circumstances helped in an immeasurable way.

Constable Abou-Arab also coordinated communication between us and the paramedics, ensuring families received timely medical attention. He helped facilitate the arrival of multiple ambulances at our parking lot, where the elderly and very young victims were assessed for smoke inhalation. A few people who had been trapped on balconies due to smoke-filled apartments were transported directly to the hospital from the Clubhouse on

priority. Beyond these efforts, Constable Abou-Arab actively helped manage the crowd, guided families to and from the clubhouse. His presence was a source of comfort during a chaotic and frightening situation, and his dedication to serving the community was truly commendable.

My colleague and I were extremely grateful for his unwavering support. It is very important to recognize officers like Constable Abou-Arab who exemplify the values and commitment of the Ottawa Police Service. His actions reflect positively on your department and serve as a reminder of the vital role law enforcement plays in safeguarding our community. Please extend my sincere gratitude to Constable Abou-Arab for his outstanding efforts. I believe his dedication and professionalism deserve acknowledgment. Best regards.

Excerpt from Letter: On behalf of myself and our team at Capital Funeral Home and Cemetery, please extend my gratitude to Staff Sgt. Coady, with whom I spoke with on Thursday, for facilitating a request regarding traffic control.

We are located at 3700 Prince of Wales Drive, and at any given time of day it can be challenging to make a left hand turn onto Prince of Wales Drive due to traffic volume and at time the excessive speed of some of the traffic.
