## APPLICANTS' PROPOSAL / PURPOSE OF THE APPLICATIONS

The Applicants want to subdivide the property into two separate parcels of land to create a new parcel for the construction of a two-storey detached dwelling, as shown on plans filed with the application. The existing dwelling will remain and the existing garage will be demolished.

#### **CONSENT REQUIRED**

The Applicants seeks the Committee's consent to sever land. The property is shown as Parts 1 and 2 on a draft 4R-plan filed with the applications and the separate parcels will be as follows:

The severed land, shown as Part 1 on the draft 4R-plan, will have a frontage of 12.65 metres, a lot depth of 45.61 metres and a lot area of 577.1 square meters and will be known municipality as 6A Basswood Avenue.

The retained land, shown as Part 2 on the draft 4R-plan, will have a frontage of 22.71 metres, a lot area of 45.60 metres and a lot area of 1035.1 square metres and will is known municipally as 6 Basswood Avenue and contain the existing dwelling.

Approval of these applications will have the effect of creating a separate parcel of land that will not be in conformity with the requirements of the Zoning By-law and therefore, a minor variance applications (File Nos) have has been filed and will be heard concurrently with this applicationthese applications.

## **REQUESTED VARIANCES**

The Applicants seek the Committee's authorization for the following minor variances from the Zoning By-law:

## A-00018: 6A Basswood Avenue, Part 1 on 4R-plan, proposed detached dwelling:

- a) To permit a reduced lot width of 12.65 metres, whereas the By-law requires a minimum lot width of 20 metres.
- b) To permit a reduced lot area of 576.81 square metres, whereas the By-law requires a minimum lot area of 600 square metres.
