On the <u>24th day of September 1996</u>, Manuel Cardoso and his spouse Gloria Cardoso bought the property to be severed. The property is municipally known as 328 Mackay Street in Ottawa but is also known as 100 lvy in Ottawa. It is shown as **part 0185** on the PROPERTY INDEX PLAN herein attached. It is located on the corner of MacKay Street and Ivy Street in Ottawa.

The house on the property is a detached single-family residence completely detached and separated from all neighbours including and more particularly to 330 Mackay Street.

On the 2<sup>nd</sup> day of December 1997, Manuel Cardoso and Gloria Cardoso bought the property municipally known as 330 Mackay Street in Ottawa, a property adjacent to their property. This property 330 Mackay Street, shown as **part 0186** on PROPERTY INDEX PLAN herein attached.

Julia Cardoso is the executrix and <u>sole</u> beneficiary of the estate of her mother Gloria Cardoso who is the registered owner of 328 Mackay Street as per the attached parcel register.
