WHEREAS on March 11, 2020 the World Health Organization declared the COVID-19 viral disease a pandemic, and

WHEREAS the COVID-19 pandemic has been unprecedented in its far-reaching impacts, including collective trauma, on individuals, families, children and vulnerable communities, and

WHEREAS the impacts of COVID-19 continue to be felt in overburdened and under-resourced health care systems and a range of other public services that have still not fully recovered from the pandemic, and

WHEREAS as of January 2024, more than 80% of Canadians had been infected with COVID-19 and by September 2024, 60,871 Canadians had died from COVID-19, and

WHEREAS as of January 2024, 1,302 Ottawa residents had died due to COVID-19, not taking into account the number who are impacted where family died elsewhere nationally or internationally, and

WHEREAS the WHO has advised that global communities transition from COVID-19 emergency approach to a longer-term disease management approach, sustaining capacity for public health

responses, community education and awareness based on emerging realities and risks, and

WHEREAS the leadership and front line workers at Ottawa Public Health, as well as health and social service agencies including hospitals across the City of Ottawa, worked tirelessly and effectively to guide the City of Ottawa through the COVID-19 pandemic, and continue to monitor and respond to a vast range of pandemic-related impacts, and

WHEREAS in March 2021, the Government of Canada designated March 11, 2021, as a National Day of Observance to commemorate the people who lost their lives and the significant impacts we have all felt because of COVID-19, and

WHEREAS March 11 will mark the fifth anniversary of the declaration of COVID-19 as a world-wide pandemic,

THEREFORE BE IT RESOLVED that Ottawa City Council join the federal government in designating March 11, 2025, as a Day of Observance to commemorate the people who lost their lives and the significant impacts we have all felt because of COVID-19,

THEREFORE BE IT RESOLVED that the 2025 Day of Observance of the fifth anniversary of the COVID-19 pandemic be marked by a flag at half-mast in front of the Heritage Building at City Hall on March 11, 2025.

#### 18.2 <u>International Women's Day</u>

WHEREAS in 1910 women delegates from around the world met in Copenhagen to propose that Women's Day become an international event to promote equal rights for women; and

WHEREAS the first International Women's Day was held in 1911 with the support of over a million people; and WHEREAS in 1977, the General Assembly of the United Nations officially called for all countries to mark a day for the recognition of women's economic, political and social achievements; and

WHEREAS municipalities can play a profound role in promoting and advancing gender equity; and

WHEREAS local and international activists, organizations, and affected communities have shown us more work is required to achieve gender equity; and

WHEREAS every year thousands of events are held around the world to inspire, celebrate and honour women.

THEREFORE BE IT RESOLVED THAT Ottawa City Council declare March 8, 2025, to be International Women's Day in the City of Ottawa.

WHEREAS the Provincial Planning Statement came into force on October 20, 2024.

WHEREAS staff made a submission to the Minister on October 4, 2024 requesting a transition period for 3 matters:

- A transition that the PPS 2024 policies, including Policy 2.1.1. for the incorporation of Ministry of Finance population projections as the basis of growth projections occur at the time of the Official Plan review cycle.
- Similarly, a transition that any policy that is to be informed by Provincial guidelines, including incorporation of the Ministry of Finance population projections as the basis of growth

- projections, does not apply until the applicable Provincial guidelines are made available to municipalities.
- A four-month transition period before private applications for settlement area boundary expansions can be received, allowing municipalities the opportunity to amend their Official Plans to process such applications

WHEREAS the Province did not establish any transition provisions. WHEREAS the Official Plan requires an update relating to settlement area boundary expansions, strategic growth areas, major transit station areas, employment areas, residential uses within Agricultural Resource Areas, cultural heritage resources, and other changes to the PPS 2024.

WHEREAS Section 26 of the Planning Act requires a 'special meeting' be held to discuss an update the Provincial Planning Statement and is sanctioned by Council.

THEREFORE BE IT FURTHER RESOLVED Council delegate to a Joint Meeting of Planning and Housing Committee and Agriculture and Rural Affairs Committee the authority for the special meeting under Section 26 to discuss the Provincial Planning Statement related updates to the Official Plan.

BE IT FURTHER RESOLVED THAT such meeting should, if possible, be held in April, 2025.

WHEREAS the parish has requested the ability for their parishioners to use the Mooney's Bay Park parking lot during the Easter season, in keeping with past arrangements; and

WHEREAS, with 1600 families in the parish, there have been community concerns with accommodating overflow parking on the local residential streets during the Orthodox Easter period; and

WHEREAS parking at City parks for unrelated uses is generally not permitted if it is unrelated to use of the park; and

WHERAS the Parks and Facilities By-law 2004-276 provides the general hours of operation of parks is 5 a.m. to 11 p.m.;

THEREFORE BE IT RESOLVED that Council approve the issuance of a park permit to allow the St. Elias Antiochian Orthodox Parish to use the Mooney's Bay Park parking lot during their Orthodox Easter events on the following dates and times:

- Sunday April 13 from 9:30 a.m. to 1:30 p.m.
- Friday April 18 from 5:30 p.m. to 9:30 p.m.
- Saturday April 19 from 9 p.m. to 2 a.m.
