Update report ACS2024-PWD-RPS-0003 includes the implementation
of paid on-street parking, including along
the main street corridor on Somerset Street West, Wellington Street
West and much of Richmond Road in Kitchissippi ward; and
WHEREAS the recommended implementation is in alignment with
the Rate Setting

Guidelines within the Municipal Parking Management Strategy approved by Council; and,

WHEREAS the businesses located on these streets have become reliant on the

availability of street parking in proximity to their location for staff and owner parking; and

WHEREAS concerns have been raised by businesses related to accommodating parking for employees when paid parking is implemented which coincides with a requirement to find alternatives to private vehicle parking, including using alternate modes of transportation; and,

WHEREAS Westboro is not yet served by light rail, and will not be served by light rail until at least the end of 2026;

THEREFORE BE IT RESOLVED that the commencement of paid street parking in the areas recommended in this report not begin until the Stage 2 extension of light rail enters revenue service.
