- The surface storm water runoff including the roof water must be self-contained and directed to the City Right-of-Way, not onto abutting private properties as approved by Planning, Development and Building Services Department.
- This property does not have frontage on a storm sewer.

## **Planning Forestry**

There are no tree-related concerns with the requested variance. Through preconsultation, it was confirmed this proposal would have no impact on existing protected trees. The applicant is responsible to ensure tree protection fencing is installed and maintained through the duration of construction.
