#### **BACKGROUND**

Within the broad array of housing matters within the City of Ottawa, student housing remains a significant one and is the main focus of the appended report. Housing and

making Ottawa a more livable and affordable city for all residents remains one of the 2023 to 2026 Term of Council priorities. In alignment with this priority, the City of Ottawa continues to follow the 10-Year Housing and Homelessness Plan to guide its actions and initiatives on housing matters for the years 2020-2030. As illustrated in the 2023 Progress Report on the 10-Year Housing and Homelessness Plan, some trends have been captured with regards to student housing. In particular, these trends relate to an increase in rooming house stock in 2023, as a result of increased interest from both students and single professionals. In 2024, the Government of Ontario also amended legislation in order to exempt publicly assisted universities from certain requirements under the *Planning Act* in order to accelerate the construction of student housing at Ontario universities. Further to this, the Government of Canada has also incentivized the construction of student housing under programs such as the Apartment Construction Loan Program, which offers low-cost loans to build more student housing on- and off- campus for universities.

The appended report compiled by the University of Ottawa Students' Union (UOSU) builds on these trends with both qualitative and quantitative analysis of the state of student housing within the city this year. The report rises from the Student Housing Exploratory Caucus (SHEC), a student-led caucus of the Board of Directors of the University of Ottawa Student Union (UOSU). The mandate of the group, as established in June of 2024, was "exploring and developing a report by the end of the current UOSU term on the state of student housing in Ottawa with a particular focus given to the dense student area of Sandy Hill." The report illustrates the findings of the survey conducted by SHEC and furthers policy recommendations for all levels of government in Ottawa.
