BACKGROUND

Every year, Ottawa Public Health (OPH) publishes an Annual Report to communicate about its work of promoting and protecting the community's health, thank community partners for their commitment to collaborating for improved health of Ottawa residents and visitors, and meet requirements under the *Ontario Public Health Standards* (OPHS). In addition to its duties and responsibilities under the *Health Protection and Promotion Act* (HPPA), the Board shall, at the request of the City, make an annual report to the City on the Board's operations, pursuant to the *City of Ottawa Act, 1999*, section 12(7). Further, in November 2016, City Council approved a recommendation requiring that annual reports from its local boards must be in writing and include the following: mandate, strategic directions, annual highlights and a financial statement.

OPH's 2024 Annual Report, attached as Document 1 (English version) and Document 2 (French version), fulfils the above-referenced requirements.

DISCUSSION

The Annual Report highlights some of OPH's key achievements of 2024 in protecting the health of Ottawa's community. The report includes:

- **Expanded access to care** through over 16,500 visits at Neighbourhood Health and Wellness Hubs, offering services like immunizations, dental screenings, and mental health support.
- **Improved dental services** with renovated clinics, new digital systems, and a pediatric referral program serving nearly 600 children.
- **Strengthened mental health and substance use supports**, including embedded services in high-need housing and a bilingual harm reduction course taken by over 2,000 people.

- **Advanced public health data tools**, including new dashboards for respiratory illnesses and infectious diseases.
- **Promoted climate resilience and emergency preparedness**, with updated plans and community education.
- **Supported families** through expanded parenting programs, home visits, and mental health supports for new parents.

The work highlighted in OPH's 2024 Annual Report represents only a sampling of the health unit's efforts to protect the health and well-being of Ottawa's population through prevention, promotion and protection.

OPH's work would not be possible without the efforts of its dedicated employees, volunteers, learners and the continued support of the Board of Health, partners, and the many individuals and organizations that contribute to the goal of a healthier, more equitable city for all.
