## **EXECUTIVE SUMMARY**

This report supports effective governance by summarizing OCHC's 2024 strategic results and overall accountability. It fulfills the annual reporting requirement set out in the Shareholder Direction.

In 2024, OCHC continued to innovate, with increased focus on tenant outreach, staff well-being, service enhancements, long-range financial stewardship, capital investments, new construction, governance, and equity.

As part of its commitment to accountability, OCHC engaged Ernst & Young as external auditors. They issued an unqualified audit opinion, confirming that the 2024 financial statements are fair, accurate, and consistent.

The report highlights organizational performance and progress in advancing OCHC's four strategic goals.

## **RÉSUMÉ**

Le présent rapport soutient une gouvernance efficace en résumant les résultats stratégiques et la responsabilité globale de la SLCO pour 2024. Il satisfait à l'obligation de rapport annuel prévue dans la directive des actionnaires.

En 2024, la SLCO a continué d'innover en mettant davantage l'accent sur la sensibilisation des locataires, le bien-être du personnel, d'amélioration des services, la gestion financières à long terme, les investissements en immobilisations, les nouvelles constructions, la gouvernance et l'équité.

Dans le cadre de son engagement en matière de responsabilité, la SLCO a fait appel à Ernst & Young comme auditeur externe. Ce dernier a émis une opinion d'audit sans réserve, confirmant que les états financiers de 2024 étaient justes, exacts et cohérents.

Le rapport met en évidence les performances organisationnelles et les progrès réalisés dans la poursuite des quatre objectifs stratégiques de la SLCO.

## **BACKGROUND**

## **DISCUSSION**
