## **Background and Justification:**

The Ottawa Police Service (OPS) has used Versaterm's vCAD and vRMS systems as the backbone of its operational and records management infrastructure for over 25 years. Versaterm is the sole supplier and integrator of this platform, and its add-on modules are developed specifically to enhance the functionality and community responsiveness of its core solutions.

The OPS now seeks to implement the CommunityConnect Patrol & Insights modules—proprietary solutions developed by Versaterm—as direct extensions of the existing CAD/RMS platform. These modules provide an exclusive, fully integrated suite of tools designed to enhance real-time operations, community engagement, and transparency, aligned with the OPS's strategic priorities for modernization and trust building.

Key justifications for a sole source procurement include:

- Seamless Integration: The add-ons are built by Versaterm specifically for vCAD/vRMS with deep architectural integration. No third-party solution can achieve the same level of interoperability, security, or real-time data access.
- **Fit for Purpose and Fit for Use**: The modules offer unique capabilities such as multilingual follow-up messaging, mobile-friendly surveys, Al-driven citizen interactions, and crime victim portals, which can only be leveraged through tight coupling with OPS's existing Versaterm ecosystem.
- **Proprietary Offering**: CommunityConnect is a proprietary product not available through resellers or other vendors. It is not technically or functionally replicable through any other product on the market.

- Operational and Community Impact: Only this solution meets the operational standards of a modern police service while supporting the OPS's mandate for equity, inclusion, and improved community experience with police services. Alternative products would fail to meet community expectations for accessibility, transparency, and responsiveness.
- Vendor Support and Continuity: Versaterm provides dedicated support through a Partner Success Manager, and integration is maintained by the same technical teams that support the OPS's CAD and RMS infrastructure today—minimizing risk and ensuring continuity.

Based on these factors, Versaterm is the only vendor capable of delivering the necessary compatibility, reliability, and strategic alignment. A sole source approach is therefore required to ensure secure, seamless integration and public-facing value. Failure to proceed with this sole source may delay OPS's ability to deliver on strategic objectives related to service transparency, modernization, and real-time community engagement.
