

BY-LAW NO. 2025-XXX

A by-law of the City of Ottawa to amend By-law No. 2002-189 respecting the licensing, regulating and governing of Driving School Operators and Driving School Instructors to expand a prohibited area.

The Council of the City of Ottawa enacts as follows:

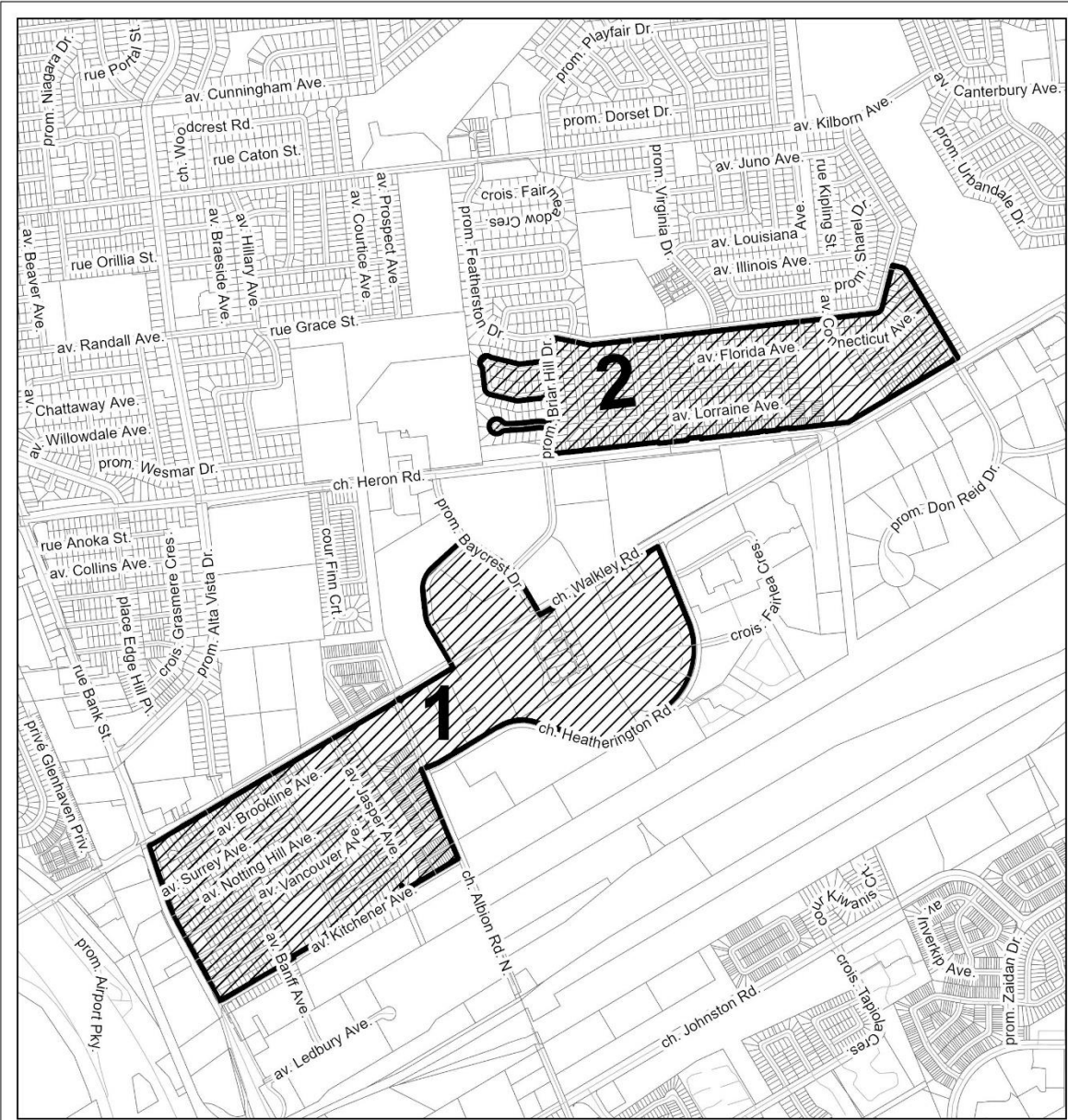
1. Schedule No. 2, relating to Driving School Operators and Driving School Instructors, of By-law No. 2002-189 entitled “A by-law of the City of Ottawa respecting the licensing, regulating and governing of certain businesses”, as amended, is amended by repealing Section 20 and substituting the following Section therefor:
  20. No licensee shall offer or provide or permit the offering or provision of driving instruction within the areas:
    - (a) bounded on the south by the north side of Montreal Road, on the east by the west side of Shefford Road, on the north by the Rockcliffe Parkway and on the west by the east side of Blair Road more particularly described in Appendix “A” and hereinafter referred to as “Area A”; or,
    - (b) described below and more particularly described in Appendix “B” and hereinafter referred to as “Area B”:
      - (i) bounded on the south by the north side of Kitchener Avenue, on the east by the west side of Heatherington Road, on the north by the south side of Walkley Road and on the west by the east side of Bank Street and bounded on the north side of Walkley Avenue, on the east by Cedarwood Drive and the west by Baycrest Drive, referred to as Section 1;
      - (ii) bounded on the south by the north side of Walkley Road and Heron Road, on the east by Briar Hill Drive, on the north by the south side of Featherston Drive and on the east by Ryder Street, including Amberdale Crescent and Garand Place, referred to as Section 2.
2. Schedule No. 2 of said by-law is further amended by repealing Appendix “B” and substituting the Appendix “B” attached hereto.
