2. MOTION – CITY RENEWABLE ENERGY

REPORT RECOMMENDATIONS:

That the Standing Committee on Environmental Protection, Water and Waste Management recommend Council:

- 1. Direct staff to report back to Council by Q2 2022 and:
 - a) Identify at least three suitable roofs at City-owned facilities to increase renewable electricity generation through leasing solar rooftop equipment for net metering;
 - Establish a working group with Hydro Ottawa and technical experts by Q2 2022 to explore the potential for enhanced community net metering and further enable distributed energy resources.

- 2. Approve that, as part of the 2023 budget process, Planning Real Estate and Economic Development, Recreation, Culture and Facilities, Infrastructure and Water Services, or Innovative Client Services consider the requirement for one full-time equivalent (FTE) position and funding to develop and implement a distributed energy resource framework;
- Approve that, contingent on sufficient resources, Council direct staff to report back to the Standing Committee on Environmental Protection, Water and Waste Management by Q4 2023 with:
 - a) An evaluation of existing solar PV systems and impact to facilities installed at City owned facilities
 - b) A distributed energy resource framework for city-owned facilities and land including:
 - i. Renewable energy generation (solar and wind)
 - ii. Energy storage
 - ii. Demand response
 - iv. Potential policies to install distributed energy resources at City facilities or on City land
 - c) Staff and funding implications to implement and support the distributed energy resource framework.

Councillor Kavanagh thanked Vice-Chair Menard for submitting this Motion on her behalf, and then spoke to provide context. Chair Moffatt also spoke to address public concerns regarding wind power in rural areas. Ms. Andrea Flowers, Section Manager, Climate Change and Resiliency, Planning, Real Estate and Economic Development Department, was also present to respond to questions.

With comments having concluded, the report recommendations were put before the Committee and were 'CARRIED', as presented.

NOTICES OF MOTIONS (FOR CONSIDERATION AT A SUBSEQUENT MEETING)

MOTION N^o EPWWM 2022 24-01

Introduced by Councillor C. McKenney:

WHEREAS the scientific consensus is clear that human activities, including fossil fuel extraction and production, are primarily responsible for accelerating global climate change; and

WHEREAS the Intergovernmental Panel on Climate Change reported in 2022 that we must halve our greenhouse gas emissions by 2030 in order to have a reasonable chance of limiting global warming to 1.5°C; and

WHEREAS global governments and the fossil fuel industry are currently planning to produce about 110% more emissions by 2030 than what is needed to limit warming to 1.5°C and avert catastrophic climate disruption, and such plans risk undoing the work of our city to reduce GHG emissions through Energy Evolution; and

WHEREAS changes in the City of Ottawa's climate are already being felt through hotter summers and increased frequency of major flooding events; and

WHEREAS the City of Ottawa declared a Climate Emergency on April 24, 2019 with the purpose of naming, framing, and deepening our commitment to protecting our economy, our ecosystems, and our community from climate change; and

WHEREAS the construction of new fossil fuel infrastructure and expanded reliance on fossil fuels exposes communities to untenable risks to public health and safety at the local and global levels and the time is now to phase-out fossil fuels and build a globally just transition for every worker, community and country; and WHEREAS a new global initiative is underway calling for a Fossil Fuel Non-Proliferation Treaty that would end new fossil fuel exploration and expansion, phase out existing production in line with the global commitment to limit warming to 1.5°C, and accelerate equitable transition plans, which complements the objective of the Paris Agreement; and

WHEREAS endorsing the Fossil Fuel Non-Proliferation Treaty reaffirms the City's commitment to Energy Evolution; and

WHEREAS over 50 cities and local governments globally, including Toronto, Vancouver, and Montreal, have formally endorsed the treaty.

THEREFORE BE IT RESOLVED THAT the Standing Committee on Environmental Protection, Water and Waste Management recommend that Ottawa City Council formally endorse the Fossil Fuel Non-Proliferation Treaty; and

BE IT FURTHER RESOLVED THAT the Mayor, on behalf of Council and the City of Ottawa, send a letter from the Mayor to the Prime Minister of Canada and the Premier of Ontario urging the Canadian and Ontario governments to support the global initiative for a Fossil Fuel Non-Proliferation Treaty.

MOTION N^O EPWWM 2022 24-01

Introduced by Councillor S. Menard:

WHEREAS the City's Urban Forest Management Plan (<u>ACS2017-PIE-EDP-0012</u>), approved by Council on June 28, 2017, was established to provide a structured approach to protecting and enhancing the environmental, social, and economical services provided by the urban forest and to ensure that it is healthy and robust into the future; and

WHEREAS the City's Urban Forest Management Plan included a recommendation for staff to undertake a Tree By-law Review; and

WHEREAS Council approved a new Tree Protection By-law on January 29, 2020 (<u>ACS2019-PIE-EDP-0052</u>), to support the protection and enhancement of the City's urban tree canopy; and

WHEREAS a motion was passed by Council on June 24th, 2020 (<u>ACS2020-OCC-ENV-003</u>), to amend the Tree Protection By-law to reduce the diameter of a Distinctive Tree within the inner urban are from 50 cm to 30 cm in diameter at breast height and a report was subsequently approved by Council to make that amendment on November 24, 2020 (<u>ASC2020-PIE-EDP-0039</u>); and

WHEREAS in the suburban area of Ottawa, the distinctive tree diameter is currently set at 50 cm in diameter at breast height in the Tree Protection By-law; and

WHEREAS the value of the tree canopy in the suburban area should be reflected equally within the provisions of the Tree Protection By-law; and

WHEREAS there is value in streamlining the provisions for Distinctive Trees within the Tree Protection By-law to reduce resident confusion and to encourage compliance with the by-law.

THEREFORE BE IT RESOLVED that the Standing Committee on Environmental Protection, Water and Waste Management recommend Council direct staff to consult with the public and bring forward a report in Q2 2023 to amend the Tree Protection By-law, 2020-340 to reduce the size of a Distinctive Tree in the suburban area of Ottawa from 50 centimeters to 30 centimeters in diameter measured at breast height.
