PURPOSE OF THE APPLICATION:

The Owner wants to subdivide its property into two separate parcels of land to create separate ownership for Phase One which is currently being developed with four mixed-use buildings and the remainder of the lands which are Phase Two and will contain three additional mixed-use buildings.

CONSENT IS REQUIRED FOR THE FOLLOWING:

The Owner requires the Consent of the Committee for Conveyance and Grant of Easement/Right-of-Way.

The severed land, shown as Parts 1 to 6 on a draft 4RPlan filed with the application, will have frontage of 162.49 metres on Brookfield Road, a depth of 97.84 metres and will contain a lot area of 15,385 square metres. This parcel will be known municipally as 750 Brookfield Road which is currently under construction.

The retained land, shown as Parts 7, 8 and 9 on said plan, will have frontage of 87.7 metres on Brookfield Road, a depth of 98.16 metres and will contain a lot area of 9,127 square metres. This parcel will be known municipally as 770 Brookfield Road will be for future development.

It is proposed to create a blanket easement over Parts 1 to 6 in favour of Parts 7 to 9 for vehicular and pedestrian access, maintenance, parking and services.

It should be noted that the property is the subject of an existing easement Instrument Number OT63570 for utilities.

THE APPLICATION indicates that the Property is not the subject of any other current application under the *Planning Act*.

YOU ARE ENTITLED TO PARTICIPATE in the Committee of Adjustment Public Hearing concerning this application because you are an assessed owner of one of the neighbouring properties. See Annex A – Public Participation Details on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

IF YOU DO NOT PARTICIPATE in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding this application, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

IF YOU WISH TO BE NOTIFIED of the Decision of the Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer of the Committee of Adjustment at the address shown below. This will also entitle you to be advised of a possible Ontario Land Tribunal Hearing. Even if you are the successful party, you should request a copy of the Decision since the Committee of Adjustment's Decision may be appealed to the Ontario Land Tribunal by the Applicant or another member of the public.

IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL against a decision of the Committee of Adjustment in respect of the proposed consent has not made a written submission to the Committee of Adjustment before it gives or refuses to give consent, the Ontario Land Tribunal may dismiss the appeal.
