1. CLIMATE RISK AND VULNERABILITY ASSESSMENT

Member B. Innes asked about the status of earlier inquiries on the subject of trees. The Coordinator informed that operational staff had been resourced to assist with efforts to help deal with the aftermath of the 21 May 2022 derecho, and that it was hoped staff might be able to address the inquiries by the Fall. Chair Nanda added that the Committee would appreciate an update on the scope of tree damage from the storm, including the number of trees damaged, the cost of property damage, the cost of planting new trees, and what strategies and funds the City might be considering to respond to future weather events.

Member P. Pisarek informed that she would be speaking before the SCEPWWM at its meeting of Tuesday, 21 June 2022 on behalf of the Centretown Community Association, on the subject of an item listed on the SCEPWWM agenda: *Motion – Anti-Idling By-Law Review And Education Campaign*.
