The Agriculture and Rural Affairs Committee received the following correspondence, a copy is held on file:

- Email dated June 4 from Ken McRae
 - Noted errors in the staff report, specifically Document 1 drainage area map, which shows non-existent parts of the Hobb's Municipal Drain.
 Figure 6.1 also shows the error.
 - Concerned that there are no proposed changes to the Arbuckle Municipal drain to accommodate proposed changes to the Van Gaal Municipal Drain.
 - Questioned if making the Van Gaal drain deeper and wider would increase the flow into the Arbuckle Municipal Drain, which flows to the Jock River, through the Village of Richmond. Questioned if the Arbuckle Drain can handle an increase in flow without any flooding occurring.
 - Expressed concern that consideration of the proposed amendment to the engineer's report is premature, because amendments to the drain are tied to a development application where there are ongoing discussions with various City departments and regulatory agencies.
- Comment sheet dated June 6 from Doug Featherstone expressing concern regarding:
 - Using the drain for urban storm water management and capacity of the drain to function in the future.
 - Implications on how land owners can use their land and on the value of the land
 - Public trespassing on his land

 entitled Van Gaal Drain, Village of Richmond, Channel Re-Alignment,
 Revision 5, dated June 5, 2016 be replaced with the drawing by Coldwater
 Consulting Ltd. entitled Van Gaal Drain, Village of Richmond ReAlignment, Revision 6 dated May 27, 2019.
