SUBJECT: 2016 Board Meeting Schedule

OBJET: Calendrier des réunions du Conseil d'administration de 2016

REPORT RECOMMENDATION

That the Ottawa Public Library Board approve the 2016 regular meeting schedule as proposed in Document 1.

RECOMMANDATION DU RAPPORT

BACKGROUND

The Public Libraries Act, Section 16 (1) requires that "A board shall hold regular meetings once a month for at least 10 months each year and at such other times as it considers necessary."

In accordance with the Board Rules of Procedure By-law as approved in January 2015, regular meetings shall be held once a month for at least 10 months of the year, and shall be held at the place and time as designated by the Board.

In 2015, Board meetings were typically held on the second Tuesday of the month.

DISCUSSION

While the Board is required to hold a meeting each month for 10 months, there is no requirement with regard to the date or time of regular meetings. Staff recommendation is to maintain consistency and continue to hold meetings on the second Tuesday of each month at 5 p.m. in the Champlain Room at City Hall, unless otherwise noted. Staff confirmed that the proposed meeting schedule does not conflict with any of the City's Council meetings, standing committee meetings, and/or other meetings.

The Board meeting schedule was developed in consultation with Trustees. It should be noted that if approved, the September meeting of the Board will occur on the first Tuesday in order to accommodate a known conflict. In addition, the meetings in September and October follow Labour Day and Thanksgiving day respectively.

In normal practice, no meetings are scheduled for the months of July and August however, Trustees are asked to reserve those dates in their calendars in case amendments are made to the schedule or a special meeting is called by the Chair.

CONSULTATION

The Board Chair and Trustees were consulted in the development of the 2016 Board Meeting schedule.

The City's room booking agent was contacted to confirm the availability of the Champlain Room for all proposed dates.

LEGAL IMPLICATIONS

The proposed 2016 Board meeting schedule complies with sub-section 16 (1) of the *Public Libraries Act* regarding a regular monthly meeting schedule (for at least 10 months of the year). The schedule also complies with Section 15 of the OPL Board Rules of Procedure By-law.
