WHEREAS Councillor Sudds has been approached by the Open City Network (OCN) to serve on the Board of Directors; and

WHEREAS OCN's mandate agree with that of the Information Technology Sub-Committee, which is to:

"investigate information technology products and services, including initiatives that stem from the Smart City Strategy to provide improved access to City services by the public, enhanced connectivity throughout the city, and an economy that is strengthened by leveraging available and emerging technologies and products."; and

WHEREAS OCN's mandate aligns with the City's Smart City Strategy, and further supports innovative and new approaches to city services that allow the needs of individuals and communities to be met proactively.

WHEREAS the Kanata North Technology Park is the largest technology park in Canada contributing over \$13 billion to Canada's GDP. With over 500 companies, many of whom are leading in the development and application of smart city technologies. The mandate of OCN, in particular the development of digital public infrastructure leveraging data standards should be of interest to the City.

WHEREAS the cost associated with travel required of the position, which is consistent with the 2010-2014 Council Mid-term Governance review, Council Member representatives are funded out of the Administrative Services budget, as approved by Council; and

WHEREAS Council members who undertake City-funded travel must submit a report (either as an information report or as an Information Previously Distributed
