WHEREAS Ottawa City Council is aware of the intention of the privatelyowned Canadian Nuclear Laboratories (CNL) to build a Near Surface Disposal Facility (NSDF) for low and intermediate nuclear waste, including plutonium and high-activity cobalt-60, at the Chalk River Laboratories on the Ottawa River; and

WHEREAS we are on unceded Algonquin, Anishinabek territory; and

WHEREAS in May of 2017, the Anishinabek Nation and the Iroquois Caucus issued a Joint Declaration that stated their opposition to the abandonment of radioactive waste on their territory as they have an "intimate relationship to the land [and] waters" and believe that they "need to protect the lands, waters and all living things for future generations"; and

WHEREAS these planned waste facilities are likely to be increasingly subject to large-scale flooding and are located in an active earthquake zone; and

WHEREAS the NSDF "engineered mound" would cover an area the size of 70 NHL hockey rinks and hold 1,000,000 cubic metres of radioactive waste, including waste transported from former reactors and nuclear research sites in Manitoba, Quebec and Ontario, as well as highly-radioactive industrial wastes from private companies; and

CNL's Near-Surface Disposal Facility proposal received support from the former Mayor of Deep River and letters of support were received from the Mayors of Deep River, Pembroke and Petawawa. The nuclear regulatory agencies (AECL, CNL and CNSC), attended at the request of Council to respond to Members' questions, and to outline their positions with respect to the CNL proposal. All other speakers, and submissions received, either advised the City to take a cautionary position, urged that the Motion be made more prescriptive, or expressed strong opposition to the NSDF proposal.

Following the receipt of all delegations (32 in total), during which time Members of Committee and Council asked questions of the presenters, Councillors posed additional questions of staff and engaged in deliberations, which touched upon many of the points in the staff presentation and those raised by the delegations. This included the need to liaise with First Nations' groups as well as suggestions that this proposal be reviewed under the *Impact Assessment Act* and that there
