BACKGROUND

In 2007 City Council approved the Crime Prevention Ottawa Terms of Reference which require that appointments to the Board be approved by City Council

In 2007 City Council approved the Crime Prevention Ottawa Terms of Reference which require that appointments to the Board be approved by City Council (City Council May 9, 2007, Agenda Item 10, CPSC Report No. 6A, Item no. 6, Report Ref. No. ACS2007-CCS-CPS-0006). As detailed in the said report to Council on May 9, 2007, Crime Prevention Ottawa:

• the Board is comprised of a mixture of Councillors and public members.

On July 11, 2012, Council approved revised Terms of Reference for Crime Prevention Ottawa to allow for a total of 16 members on the Board of Directors with 8 institutional members and 8 general representative members (7 community representatives and 1 academic). The purpose was to increase the community connections of the Board and to increase the number of Board members available for committee work (City Council July 11, 2012, Bulk Consent Agenda Item G, CPSC Report No. 15A, report ref. No. ACS2012-CMR-CPS-0008).

Section 6.2 of the Terms of Reference states that Members of the Board of Directors are appointed for a period of up to 4 years with a possibility of being renewed once.

DISCUSSION

The Crime Prevention Ottawa Board of Directors named a Nominating Committee, which undertook a recruitment process as laid out in the CPO Board Appointment Policy. Recruitment of candidates was done through a widely distributed email and our website. The policy stresses the importance of community representation, diversity of skills, diversity of demographics and inclusion. The recruitment process yielded 28 candidates. The Nominations Committee reviewed the applications, held interviews and recommend made recommendations to the January 8, 2018 meeting of the Board of Directors. The following people are the CPO Board of Directors recommended nominees to be appointed for 2018-2022: Farhia Ahmed, Reverend Anthony Bailey, Ed Buller, Steve Monuk and Meredith Porter
