OSMAN HAS BEEN INVOLVED WITH MANY LOCAL ORGANIZATIONS, INCLUDING CARNY HOUSE, A TRANSITION HOUSE FOR REFUGEE WOMEN, THE CANADIAN HEARING SOCIETY, THE CANADIAN TOY TESTING COUNCIL AND UNICEF. HE WAS RECOGNIZED AS AN EVERYDAY HERO IN 2017 THROUGH THE UNITED WAY'S ONGOING COMMUNITY BUILDER AWARD. I WAS VERY PLEASED YESTERDAY WHEN THE GOVERNMENT OF CANADA ANNOUNCED THAT IT WILL BE CONTRIBUTING 73.3 BILLION DOLLARS FOR THIS GREAT CITY BUILDING PROJECT. I WANT TO THANK MINISTER MELANIE JOLY. WHO I SPOKE WITH LAST NIGHT, MINISTER OF CANADIAN HERITAGE, MINISTER CATHERINE McKENNA WHO WORKED TIRELESSLY AND THIS MORNING HAD A BREAKFAST WITH MINISTER MORNEAU, MINISTER MORNEAU INDICATED THAT SHE WAS LOBBYING HIM A HUNDRED TIMES OVER THE COURSE OF THE LAST COUPLE OF WEEKS. AS WELL AS MINISTER MORNEAU AND MEMBERS OF THE NATIONAL CAPITAL GOVERNMENT CAUCUS FOR THEIR ADVOCACY. COMMITMENT TO SECURING THESE FUNDS. IT HAS DRAWN INTERNATIONAL INTEREST FROM PROMINENT ARCHITECTURE FIRMS AND FIVE RESPONDENTS WILL BE SELECTED TO PROCEED TO THE REQUEST FOR PROPOSAL STAGE. THE ANNOUNCEMENT OF THE FIRM SELECTED THROUGH THE RFP PROCESS

WILL BE ANNOUNCED SHORTLY. ALSO IN THE COMING WEEKS, THE REPORT WILL BE COMING FORWARD TO CITY COUNCIL TO CONFIRM MUNICIPAL PROJECT FUNDING. I AM VERY EXCITED TO SEE THIS PROJECT MOVING FORWARD. UNITED NATIONS THEME FOR WOMEN'S DAY 2018 IS "TIME IS NOW."THERE REALLY IS NO DOUBT THAT THE TIME IS NOW. GOVERNMENTS, BUSINESSES AND COMMUNITIES NEED TO CHANGE BOTH BEHAVIOURS AND OLD WAYS OF DOING THINGS. I WANT TO SALUTE THE FEDERAL GOVERNMENT FOCUSED ON GENDER EQUALITY IN THE 2018 BUDGET. I AM ENCOURAGED BY THE GENDER BASED ANALYSIS APPROACH THAT WAS USED IN BUILDING THE FEDERAL BUDGET AND I AM GRATEFUL FOR THE SERIOUS APPROACH THAT THE FEDERAL GOVERNMENT IS TAKING ON GENDER BASED VIOLENCE. THE CITY OF OTTAWA NOW HAS ITS AIR QUALITY AND CLIMATE CHANGE MANAGEMENT PLAN AND ITS ENERGY EVOLUTION STRATEGY IN PLACE AND ITS TARGETS AND TO MEASUREMENTS AND THANKFULLY, AT BOTH THE FEDERAL AND PROVINCIAL LEVEL, A SIGNIFICANT AMOUNT OF FUNDING IS NOW AVAILABLE FOR A VARIETY OF INITIATIVES IN EVERYTHING FROM BUILDING RETRO FITS TO STREETS TO RAPID TRANSIT PROGRAMS AND THE CITY OF OTTAWA HAS BEEN DILIGENTLY APPLYING FOR AS MUCH OF THAT FUNDING AS WE CAN AND THIS MOTION IS A REQUIREMENT FOR THE PROVINCIAL FUNDING PROGRAMS.
