BACKGROUND

On July 13, 2016, Council approved a report titled "Sparks Street Business Improvement Area and Mall Authority Governance Review (ACS2016-CMR-OCM-0026) as well as the recommendation to **a**pprove amendments to By-law 77-92 that revise the composition of the Sparks Street Mall Authority Board to a six-member board.

By-law 77-92 as amended by By-law 2016-273 states that the Council of the City of Ottawa shall appoint the below noted six members to the Board:

(a) one of whom shall be a member of Council;

(b) one of whom shall be an individual assessed for business assessment, or tenant of such property, in respect to land in the Sparks Street Mall Authority Management Board area, or nominees of such individual or corporation so assessed;

- (c) one of whom shall be an individual assessed for business assessment, or tenant of such property, in respect to land in the Sparks Street Mall Business Improvement (BIA) area, or nominees of such individual or corporation so assessed;
- (d) one of whom shall be the City of Ottawa General Manager, Planning and Grown Management Department now referred to as the General Manager of Planning, Infrastructure and Economic Development Department, or designate, as appointed by the City Manager;
- (e) one of whom shall be a senior representative from the National Capital Commission; and
- (f) one of whom shall be a senior representative from Public Services and Procurement Canada.

DISCUSSION

Revising the composition of the Sparks Street Mall Authority Board to include a six-member board comprised of senior decision makers from each of the major stakeholders on the street results in a Mall Authority Board which can focus solely on the control, operation and management of the street, as was originally intended in the By-law. Additionally, including senior management on the Board, in cooperation with the private sector, enables a high-level platform for decision making.

Michael Swan, Director of Leasing with Brookfield, will represent property and business owners within the Sparks Street Mall Authority Management Board area and the current Chair of the Sparks Street BIA, Antoine (Tony) Kano, will represent property and business owners within the Sparks Street Mall Business Improvement area. Additionally, the NCC has identified Bill Leonard, Director of Real Estate Management, as their senior representative and PSPC has identified Nathalie Laliberté, Director General of the Parliamentary Precinct Branch. Representing the City will be the Ward Councillor as well as Court Curry, Manager of Right-of-Way, Heritage and Urban Design Services as designate for the General Manager of Planning and Growth Management Department designate.

By-law 77-92, as amended, directs that Council shall appoint members to the Sparks Street Board of Management and that such members shall hold office from the time of appointment until the expiration of the term of Council that appoints them. The appointees will therefore serve until November 30, 2018.
