SUMMARY – "MAJOR" BY-LAWS

Notes: For purposes of this summary:

- "major" is defined based on demand for service from the public, (i.e. complaints, or service requests [SRs]) which is
 consistent with Council-approved criteria used to help prioritize by-laws for harmonization following amalgamation.
 The by-laws herein are listed in order of highest to lowest demand on the basis of 2014 statistics (rounded). "Service"
 may entail request for enforcement or for information about the regulations, and also files established by By-law &
 Regulatory Services to record proactive patrol activity.
- amending by-laws listed were enacted as a result of a review of particular provisions of the by-law or of the substantive by-law as a whole to address issues, as a result of Council direction or otherwise. Amendments to fees have been excluded.
- enforcement activity includes Parking Infraction Notices (PIN tickets, issued to a vehicle), Provincial Offence Notices (PON tickets, issued to a person), Orders (written orders for compliance by a specified date, issued to a property owner for property standards violations), Notices of Violation (NOVs, written requests for compliance by a specified date, issued to a property owner for various types of violations). Other actions not captured in the enforcement activity include education, mediation, alternate response, verbal warnings, written warnings, summonses to Court, charge backs to property owners. There are various strategies and approaches applied to garner compliance, which is the primary objective of the City's regulations. Further, given evidentiary and other requirements, the issuance of charges is not always possible.
