THE ONE OTHER STORY I WANT TO SHARE WITH YOU SPEAKS AND ILLUSTRATES THE PARTNERSHIP THAT THE UNITED WAY IN THE CITY HAS HAD. AND THAT IS IN AN AREA THAT I KNOW IS TOPICAL, AND IT'S BEEN TOPICAL FOR PROBABLY AS LONG AS I HAVE BEEN WITH UNITED WAY, AND THAT IS AROUND ADDICTIONS AND DRUG ISSUES IN OUR CITY.AND IT WAS ABOUT TEN YEARS AGO THAT I SAT AROUND THIS UNABLE WITH CITY OFFICIALS AROUND THE ISSUE OF SAFE INJECTION SITES.MANY THINGS CHANGE, MANY THINGS STAY THE SAME.AND AT THE TIME, WE RESPONDED BY SEGMENTING THE PROBLEM AROUND YOUNG PEOPLE AND YOUTH.AND WHAT COULD WE DO TO TRY AND WORK UP STREAM TO PREVENT YOUNG PEOPLE FROM BEING EXPOSED TO OR MANAGING THE TEMPTATIONS OF DRUGS.AND SO A PROJECT WAS BORN CALLED PROJECT STEP, STEP STANDS FOR SUPPORT, TREATMENT, EDUCATION AND PREVENTION. AND IN THE PAST TEN YEARS. WE HAVE SEEN THE CONSTRUCTION AND THE OPENING AND THE SERVICING OF TWO PERMANENT YOUTH ADDICTION CENTRES IN THE CITY, BOTH IN FRENCH AND IN ENGLISH.WE HAVE SEEN THE DEPLOYMENT OF COUNSELLING SERVICES IN ALL OF OTTAWA'S HIGH SCHOOLS, AND NOW IN SOME JUNIOR HIGH SCHOOLS, AND IN NON-TRADITIONAL EDUCATION SETTINGS.OPERATION COME HOME AND THE UNIONVILLE CENTRE.AND LAST SPRING, THOSE AROUND THIS TABLE WILL REMEMBER, OF COURSE, THAT THE CITY HAD A BIG SCARE, AN UNDERSTANDABLE SCARE, THAT PARENTS REACHED OUT TO CITY OFFICIALS, OTTAWA PUBLIC HEALTH,

ORGANIZATIONS LIKE UNITED WAY, WHEN FENTANYL -- THE CRISIS OF FENTANYL HIT THE CITY.AND SO LIKE WE DID IN THE CONTEXT OF THE SYRIAN REFUGEE CRISIS. MR. MAYOR, AND YOU KIND OF LED US TO IT, BUT WHEN WE DEALT WITH THE RATE BUDGET.WE APPROVED, WASN'T IT 5%? RANGING ANYWHERE FROM 13.3% TO 14.1%.IN 2026, THE DEBT SERVICING IS UPWARDS OF 14.8% OF THOSE RATE REVENUES.IF WE ADD THESE \$3.1 MILLION INTO THE DEBT NOW, WHAT DOES THAT MEAN FOR THE DEBT CEILING MOVING FORWARD?WHAT ARE THE IMPLICATIONS?>> IT INCREASES IT SLIGHTLY BUT YOU'RE STILL WITHIN YOUR 15% PARAMETER.>> SO THAT'S 2026, FOR EXAMPLE, IS WHEN I THINK WE COME CLOSEST TO MEETING THE CAP AT 14.8%.>> I'D SAY 2021.>> OH, 14.9%.YOU'RE ABSOLUTELY RIGHT.>> YEAH, I THINK YOU GET TO 15% THAT YEAR BUT IT COMES DOWN AFTER THAT.>> YOU HIT 15% THAT YEAR?>> YES.>> OKAY, SO THE TOTAL DEBT SERVICING COSTS FROM 2018 TO 2027, WE'RE LOOKING AT \$638.1 MILLION.DO YOU HAVE A NEW FIGURE ON THAT IF WE PURSUE THIS COURSE TODAY?>> WE DON'T HAVE A NEW NUMBER ON THAT.WE CAN PROVIDE THAT, BUT IT'S STILL -- WHATEVER IT IS, IT'S STILL WITHIN THE 15%.SO THAT'S SORT OF OUR BENCHMARK FOR THIS PARTICULAR SERVICE AREA.>> IT WOULD BE USEFUL TO KNOW HOW MUCH MORE INTEREST COSTS WE'RE ADDING ONTO THAT NEXT -->> WE'LL PROVIDE THAT TO YOU.>> OKAY, THANK YOU.THE -- \$1.9 MILLION OF NEW DEBT SERVICING COSTS OVER THAT PERIOD.THANK YOU.WHAT DIFFERENCE WILL THIS MAKE BY GOING FROM -- AND I DON'T REMEMBER WHAT THE FIGURE WAS, 13% DOWN TO 5%, WHAT DIFFERENCE WILL THAT MAKE IN THE AVERAGE RURAL USER'S BILL IN REAL DOLLARS?>> SO THE AVERAGE INCREASE FOR RURAL NOT CONNECTED WOULD BE \$1.40 PER YEAR, FOR URBAN NOT CONNECTED, \$1.95 PER YEAR, AND FOR THOSE THAT ARE CONNECTED, THEY GET A WATER BILL, IT WOULD BE ABOUT \$5.50.>> OKAY.SORRY, THAT'S THE NEW RATE AT THIS -- WITH THE ADDITIONAL \$2 MILLION IN DEBT FINANCING?>> CORRECT.>> AND WHAT WOULD IT TO BE, RATE PAID PREVIOUS TO OUR DOING THIS?>> PREVIOUS, USING THE 13% OR THE 5% IS.>> YEAH, USING THE 13%.>> SO I HAVE THE FIGURE FOR RURAL, IT WOULD HAVE BEEN \$3.50.>> SO IT'S BRINGING IT DOWN FROM \$3.50 TO ABOUT -- SORRY, YOU SAID \$1.50?>> \$1.40.>> \$1.40.OKAY.WHAT ABOUT THE 2019, 2020, 2021 YEARS?WHAT ARE WE ANTICIPATING THOSE RATES WOULD BE?THE SAME AS WHAT IS IN THE REPORT?>> WE WILL BE BRINGING BACK FURTHER INFORMATION BEFORE WE DETERMINE WHAT THE 2019 RATE WILL BE, BECAUSE WE'VE BEEN ASKED TO GO BACK AND LOOK AT A NUMBER OF DIFFERENT NON-FINANCIAL STRATEGIES AND

ALSO ADDITIONAL FINANCIAL STRATEGIES.ONE OF THE THINGS WE'RE AWARE OF. BECAUSE MOST OF WHAT'S HAPPENING IN YOUR STORMWATER WORLD IS THE RESULT OF CLIMATE CHANGE, IS THAT WE KNOW THE FEDERAL AND PROVINCIAL GOVERNMENTS ARE CONSIDERING PROGRAMMES TO ASSIST US WITH DEALING WITH THAT, AND IF THEY DO, THEN THAT WILL IN FACT CHANGE WHAT WE WERE PROJECTING FOR 2019 AND ONWARD.BUT YOU'LL HAVE SOMETHING, WE'LL BRING SOMETHING BEFORE THE FIRST COUNCIL, THE FIRST -- IN THE NEXT TERM, BEFORE THEY SET THE 2019 BUDGET FOR THE RATE SERVICE AREAS.>> BECAUSE IF YOUR INTENTION IS TO KEEP THAT INCREASE TO ROUGHLY THAT 5% OR SO, I WOULD BE REALLY LOATHE TO SEE US ADDING \$3 MILLION, WHATEVER THE NUMBER IS TODAY. \$3.1 MILLION, EVERY YEAR WHEN THOSE INTEREST COSTS ARE ADDING \$1.9 MILLION IN OUR DEBT SERVICING. THAT'S A BURDEN THAT YOU'RE PUTTING ON, YOU KNOW, FUTURE TAXPAYERS, FUTURE RATEPAYERS.SO HOPEFULLY WE ARE COMING UP WITH SOMETHING OTHER THAN JUST BORROWING MORE EVERY YEAR IN ORDER TO KEEP TO THAT 5%, PARTICULARLY WHEN, AND YOU KNOW, COUNCILLOR HARDER HAS SPOKEN ABOUT THE PRINCIPLE THAT IS IMPORTANT, BUT IN REAL DOLLARS, THAT \$2 A YEAR SEEMS -- IT'S NOT WORTH PUTTING OUR FUTURE GENERATIONS EVEN MORE IN DEBT TO TAKE CARE OF THAT.>> THIS COUNCIL HAS MANDATED THAT WE CAN ONLY GO UP TOP 15%. SO WE ARE THERE. SO THERE'S THE POSSIBILITY OF ADDING MORE DEBT ON IS NOT ONE THAT'S LIKELY TO HAPPEN.>> WE DON'T HAVE THAT WIGGLE ROOM.>> EXACTLY.>> YEAH.THANK YOU VERY MUCH, CHAIR.>> THANK YOU, COUNCILLOR CHIARELLI, PLEASE.>> THANK YOU, YOUR WORSHIP.OKAY, ON THE MAIN PART OF THIS, DO YOU WANT COMMENTS ON THE MAIN PART OR DO YOU -->> WELL WE'RE ON ITEM NUMBER SIX RIGHT NOW SO YOU CAN SPEAK TO EITHER THE AMENDMENT OR THE MAIN REPORT, WHICHEVER YOU SUPPORT.>> OKAY.SO WHEN DO WE ESTABLISH THE DEBT CEILING AT 15%?>> IN THE LAST LONG RANGE FINANCIAL PLAN THAT YOU DID IN 2012.>> OKAY, AND CAN YOU REMIND COUNCIL WHAT WE USED TO DO?>> BEFORE WE HAD A 7.5% CEILING FOR THE ENTIRE CITY, BUT RECOGNIZING THAT WATER AND SEWER, WHICH IS BASICALLY A UTILITY, IS SO CAPITAL-INTENSIVE, KEEPING IT AT 7.5% DIDN'T ALIGN WITH WHAT WE SAW ACTUALLY REAL UTILITY COMPANIES HAVING AS THEIR DEBT TO EQUITY RATIO.AND I THINK IN THE REPORT WE TALK ABOUT THAT.MOST UTILITY COMPANIES RUN AROUND 26% IN DEBT, SO EVEN AT 15%, WE'RE CONSIDERABLY LESS THAN MOST UTILITY COMPANIES. IF THIS SERVICE WAS NOT SO CAPITAL ASSET-INTENSIVE. IMPACT BECAUSE WHAT, IF, FOR EXAMPLE, YOU HAD \$100 MILLION DEBENTURE THAT RETIRED, BUT THE RATE CHANGED SO THAT THE RATES WENT UP, WE ACTUALLY ONLY WOULD ISSUE ENOUGH DEBT THAT CORRESPONDS TO HOW MUCH DEBT SERVICING IS BUILT INTO THE BUDGET SO THAT COULD TAKE IT DOWN TO SAY \$90 MILLION IF THE RATES WENT UP.SO WE DON'T WORK WITH THE ACTUAL DEBT THAT'S RETIRING, WE WORK WITH THE DEBT SERVICING THAT'S AVAILABLE, AND WE ISSUE THE DEBT TO FILL THAT DEBT SERVICING CAPACITY.BUT I CAN TELL YOU THAT WHEN WE BUILD THESE LONG RANGE FINANCIAL PLANS FOR YOU, WE TAKE A FAIRLY CONSERVATIVE APPROACH WITH RESPECT TO WHAT THE INTEREST RATE IS GOING TO BE.WE DO NOT GO WITH TODAY'S LOW RATES.WE KNOW THAT THEY'RE GOING UP, SO WE AVERAGE IT OUT AND WE WILL TAKE A MORE CONSERVATIVE 4.5% OR 5% FOR A DEBT RATE WHEN WE'RE ACTUALLY ISSUING AT PROBABLY 3.5% TODAY.>> OKAY, SO THIS ALL MAKES SENSE, AS LONG AS IT'S WITHIN THAT RANGE.BUT AT WHAT INTEREST RATE LEVEL DO WE HAVE TO SAY THIS WILL EITHER BREAK OUR CEILING OR WE HAVE TO RE-EVALUATE THE APPROACH.>> ONCE YOU GET PAST WHAT WE'VE BUILT IN THE AS OUR ASSUMPTIONS, WHICH WOULD BE THE 4.5% TO 5% WE BUILT IN THERE, ONCE WE'RE PAST THAT, YES, YOU WILL NOT BE ABLE TO --YOU'LL EITHER HAVE TO CHANGE THE LIMIT OR WE'LL HAVE TO CONSTRAIN THE AMOUNT OF DEBT AND USE CASH, BUT WE WOULD BRING THAT BACK TO YOU WELL IN ADVANCE OF THAT TO WARN YOU THAT WE'RE REACHING THAT.>> OR WE COULD ALSO DO FEWER PROJECTS, RIGHT?>> YES, THAT'S ALWAYS AN ALTERNATIVE, IS TO DO LESS WORK.BUT I BELIEVE THIS COUNCIL HAS COMMITTED TO GOOD STATE OF REPAIRS ASSETS, SO THAT, I'M CERTAIN, WOULD BE A VERY DIFFICULT DECISION.>> ALL RIGHT.>> THANK YOU, COUNCILLOR.COUNCILLOR QAQISH, PLEASE.>> THANK YOU, MR. MAYOR.ON THE MOTION IN THE FIRST THEREFORE, CAN STAFF EXPLAIN TO ME WHAT NEW INFORMATION WE WOULD BE GETTING BACK IN THIS REPORT THAT WE HAVEN'T ALREADY HAD PRESENTED TO US AT COMMITTEE OR COUNCIL IN THE PAST?>> YOU'RE REFERRING TO THE LONGER TERM FUNDING STRATEGIES?IS THAT THE PART OF -->> WELL, IT MAKES IT SOUND -- YEAH, THE FIRST THEREFORE, BUT IT ALSO MAKES IT SOUND THAT WE'RE GOING TO BE GETTING NEW INFORMATION THAT WE DIDN'T HAVE IN TERMS OF THE LIST OF PROJECTS OR PERHAPS MORE DETAILS. THAT WE GET.I'M NOT SURE WHAT EXACTLY WE'D BE RECEIVING IN THAT REPORT THAT WE HAVEN'T ALREADY RECEIVED AND VOTED ON.>> I CAN ONLY SPEAK, I CAN SPEAK TO THE FINANCIAL -->> SORRY, I BELIEVE -- I THINK, AS I UNDERSTAND IT IN DISCUSSIONS, WE WANTED TO PROVIDE A LIST OF THOSE PROJECTS THAT WOULD BE ABOVE AND BELOW THE LINE AS NEW INFORMATION.I KNOW A NUMBER OF COUNCILLORS WANTED THAT INFORMATION AND THAT WOULD BE ONE ASPECT THAT WE WOULD BE ABLE TO PROVIDE MUCH MORE DETAIL AS TO WHAT'S GETTING DONE IN EACH WARD, DITCHES, CULVERTS, SO ON.IS THAT CORRECT, TREASURER?>> I BELIEVE SO, IS I'LL ASK MR. GONTIER TO RESPOND WHAT, THAT WAS RAISED AT THE ENVIRONMENT COMMITTEE.>> MR. MAYOR, WE DID INDICATE THAT WE WOULD BE

ABLE TO PROVIDE DIRECTLY IN DISCUSSIONS WITH COUNCILLORS IN TERMS OF WHAT WE'RE ANTICIPATING IN TERMS OF WORKS TAKING PLACE, I THINK WHEN WE LOOK AT THE MOTION IN TERMS OF WHAT ADDITIONAL INFORMATION COULD BE FORTHCOMING, WHEN WE LOOK AT THE COMPREHENSIVE ASSET MANAGEMENT REPORT, WE DO SPEAK TO NON-FINANCIAL STRATEGIES.A LOT OF IT IS LOOKING AT OUR LEVEL OF SERVICE BECAUSE THE FUNDING INVESTMENTS THAT WE PROVIDE AROUND OUR ASSETS, IT'S THE SUPPORT SERVICES TO THE PUBLIC.SO WHAT WE'RE GOING TO BE LOOKING AT IS A LOT MORE CLOSELY, IN TERMS OF LEVEL OF SERVICE THAT WE'RE PROVIDING AND THE LEVEL OF FUNDING THAT'S REQUIRED TO SUPPORT THOSE LEVELS.AND THAT'S INFORMATION THAT WE'LL BE BRINGING FORWARD BACK TO COUNCIL EARLY NEXT TERM.AND THAT'S GOING TO HELP TO INFORM THE FUTURE RATE PROJECTIONS.>> OKAY, THERE WAS A BIT OF DISCUSSION HERE IN HOT BACK SO I DIDN'T GET ALL OF IT, BUT WE ALREADY HAVE A WORKING LIST OF INFRASTRUCTURE PROJECTS, AND YOU SEND US SOME OF THOSE REGULARLY, SO I'M STILL -- IF YOU CAN REPEAT THE ANSWER AGAIN, OR CLARIFY WHAT THE NEW INFORMATION WOULD BE THAT WE'D BE RECEIVING THAT'S BEING ASKED FOR IN THE MOTION.>> MR. MAYOR, THERE WERE -- I THINK WE WERE POINTING TO TWO DIFFERENT ITEMS.MR. MAYOR WAS POINTING TO THE FACT THAT SOME OF THE COUNCILLORS HAD ASKED FOR MORE DETAILS AROUND THE WORKS THAT WOULD BE TAKING PLACE IN THEIR WARDS IN TERMS OF WHAT'S ABOVE THE LINE AND BELOW THE LINE.THAT'S SOMETHING THAT WE COMMITTED TO PROVIDING. WHERE COUNCILLORS SO WISH. SPECIFIC TO THE MOTION, WHEN WE'RE TALKING ABOUT ADDITIONAL WORK TO COME BACK BEFORE THE NEXT, EARLY NEXT TERM OF COUNCIL, IT'S FOCUSED MAINLY ON FINANCIAL-TYPE STRATEGIES, THE KEY TO THAT IS LEVEL OF SERVICE.LOOKING AT OUR LEVEL OF SERVICE, INCLUDING ON THE STORMWATER SIDE AND OUR WATER AND WASTEWATER, TO BE ABLE TO REINFORM OUR LONGER RANGE PROJECTIONS.AND THAT'S BASICALLY IDENTIFYING WHICH PROJECTS ARE REQUIRED TO SUPPORT THAT LEVEL OF SERVICE.>> BUT IN TERMS OF THE CAPITAL LIST, WE'RE NOT GOING TO EXPECT ANY BIG CHANGES, YOU HAVE A CAPITAL LIST OF INFRASTRUCTURE THAT YOU NEED TO UPGRADE AND INVEST IN.SO THAT'S -->> CORRECT, AND THE CAPITAL LIST IS TYPICALLY PROVIDED THROUGH THE BUDGET PROCESS AND THAT WILL BE PROVIDED AGAIN AS PART OF THE 2018 BUDGET.AS PART OF THAT PROCESS, WE ALWAYS ALSO PROVIDE COUNCILLORS WITH AN OUTLOOK IN TERMS OF WHAT WE'RE ANTICIPATING IN FUTURE YEARS.WE WILL CONTINUE TO PROVIDE THAT LEVEL OF DETAIL. THE ASSESSMENT THAT WE'RE REALLY LOOKING AT IS BASICALLY LOOKING AT IN THE LONGER TERM IN TERMS OF WHAT ARE THE OVERALL INVESTMENT LEVELS THAT ARE REQUIRED TO SUPPORT OUR ASSETS, THE BUDGET PROVIDES THE SPECIFIES IN TERMS OF THE ACTUAL PROJECTS THEMSELVES.>> OKAY, SO THAT 13% WOULD BE GOING TO CAPITAL PROJECTS THAT NO MATTER WHAT YOU CAME BACK WITH, THIS NEW INFORMATION THAT WON'T BE IMPACTED BY THAT BECAUSE THOSE ARE PROJECTS THAT YOU

NEED TO PAY THROUGH THAT INCREASE THAT YOU'RE ASKING FOR IS THAT FAIR?>> CORRECT.I THINK WHEN WE'RE LOOKING AT THE REDUCTION FROM THE 13% IT'S BEEN OFFSET BY THE FACT THAT THERE IS MORE DEBT.SO THE PROJECTS THAT WE WERE ANTICIPATING FOR 2018 WILL STILL BE PROCEEDING.>> AND SO WE'RE NOT DELAYING ANY PROJECTS BY DOING THIS, BECAUSE YOU'RE FINDING THAT SOURCE OF FUNDING FOR THIS IN THE NEXT YEAR, BUT IN TERMS OF THE INTEREST COSTS THAT WAS ON THE DEBT FINANCING IS THAT THE ONLY ADDITIONAL COST THAT \$1 MILLION SOME.WE'RE NOT DOING CONSTRUCTION COSTS WHICH MEANS ALSO HIGHER COSTS IN THE FUTURE FOR TAXPAYERS.>> THERE'S ALSO AN ADDITIONAL \$500,000, I BELIEVE IT'S ALSO IN THE MOTION, THAT WE'RE DEDUCTING FROM THE CAPITAL INVESTMENT.>> OKAY.SO \$500 PLUS THE INTEREST THAT YOU REFERRED AS A RESULT OF -->> WELL, WE'RE REDUCING CAPITAL INVESTMENT BY \$500,000 AND THE 1.% IS AN INCREASE TO DEBT.>> SO THAT IS A DELAY OF CONSTRUCTION PROJECTS.>> MR. MAYOR, IN TERMS OF THE QUANTUM, THAT QUANTUM WOULD ACTUALLY BE REDUCED FROM A CULVERT RENEWAL ACCOUNT EVERY YEAR.WE KNOW THERE'S CULVERTS THAT WILL FAIL SO WE ALWAYS PROVIDE BASICALLY FUNDING SET ASIDE TO BE ABLE TO ADDRESS THOSE MORE EMERGENCY NATURE OF REPAIRS.THAT'S THE FUND THAT WE SET ASIDE, THE \$500 WOULD BE DRAWN FROM THAT ACCOUNT.>> BUT I THINK DEPUTY TREASURER, WE SHOULD REMIND MEMBERS, WE'RE GOING FROM \$64 MILLION TO \$83 MILLION, SO, YOU KNOW, THAT'S A SIGNIFICANT INCREASE, AND I KNOW EVERY MEMBER OF COUNCIL WAS CONCERNED THAT WE DON'T WANT TO FALL BEHIND ON BASIC INFRASTRUCTURE.SO I THINK I GIVE GREAT CREDIT TO OUR RURAL COLLEAGUES ALONG WITH COUNCILLORS HARDER AND EGLI WHO HAVE A RURAL COMPONENT TO THEIR WARDS FOR COMING UP WITH, I BELIEVE, A VERY SENSIBLE COMPROMISE THAT ALLOWS US TO GO FROM \$646 MILLION TO \$838 MILLION TO GO WITH CULVERT. DRAINS, STORMWATER ISSUES AND AT THE SAME TIME BRING THE INCREASE DOWN FROM, I BELIEVE, 13% TO 5%, WHICH IS IN LINE WITH WHAT WE ALL VOTED ON EARLIER THIS YEAR.IS THAT CORRECT, JASMINE?>> CORRECT.>> COUNCILLOR QAQISH, WOULD YOU LIKE TO CONTINUE?>> NO, I'M GOOD.THANK YOU.>> THANK YOU.DOES ANYONE ELSE WISH TO SPEAK OR ASK QUESTIONS BEFORE WE ASK COUNCILLOR CHEMUSHENKO TO FORMALLY WRAP UP AS THE CHAIR OF THE COMMITTEE?COUNCILLOR MOFFATT?>> THANKS.I DON'T WANT TO TAKE TOO MUCH TIME, I JUST WANT TO THANK THE PEOPLE INVOLVED IN THE PAST WEEK.OBVIOUSLY THESE ARE -- AS I MENTIONED LAST WEEK, THIS IS SOMETHING THAT I WOULD HAVE PREFERRED TO BE INVOLVED WITH EARLY ON, TO AVOID A LOT OF THE TALK AND ANGST THAT WAS CREATED LAST WEEK, BUT I DO APPRECIATE THE ABILITY FOR THE MAYOR'S OFFICE, AND COUNCILLOR CHEMUSHENKO, COUNCILLOR EGLI, COUNCILLOR HARDER, COUNCILLOR DERUIZ, AND MANY OTHER COUNCILLORS WE SPOKE WITH OVER THE LAST WEEK AS WELL AS MR. GONTIER AND JASMINE ON TRYING TO ACCOUNT FOR SOMETHING THAT WAS AMENABLE AND CONSISTENT WITH WHAT WE HAD DONE IN THE PAST.ONE OF THE BIG CONCERNS THAT WE HAD HEARD AT THE MEETINGS THAT WE HAD ON THE STORMWATER RATE WAS THIS FEAR THAT ONCE WE SEPARATED THE RATES, WE WOULD THEN JACK UP THE INCREASES ON STORMWATER SIDE.AND I KNOW \$1.40, \$3.50, IT SOUNDS LIKE NOTHING, BUT IT IS, AS COUNCILLOR HARDER SAID, IT IS THE PRINCIPLE, THAT YOU HAVE INCREASES OVER THE YEARS WHERE IT'S 6% EVERY YEAR, 5% EVERY YEAR AND THE SECOND THAT YOU REMOVE THE RATE, THEY GO UP 5% BUT THE STORMWATER GOES UP 13%, THE OPTICS ARE INCREDIBLY POOR.YOU'RE A SECOND YEAR IN A 1-YEAR PHASE-IN, AND WE'RE RECOMMENDING A MAJOR INCREASE IN THE PERCENTAGE.NOT THE DOLLAR.WE CAN GO THROUGH THE BUDGET.THERE'S PAGES UPON PAGES OF FEES AND SERVICES IN THE CITY OF OTTAWA, THAT WE CHARGE LESS THAN \$50.WE CAN INCREASE EVERY SINGLE ONE OF THOSE FEES BY \$4, \$5 EACH, IT WOULD BE IRRELEVANT BECAUSE IT'S ONLY \$4 OR \$5.A PERCENTAGE INCREASE IT COULD BE A 20% INCREASE.WE'D BE UPSET ABOUT THAT.SURE THE DOLLAR AMOUNT IS MINOR, YOU CAN'T GET CAUGHT UP WITH THE DOLLAR AMOUNT BECAUSE AS YOU ADD THEM ALL UP, EVENTUALLY IT STOPS BEING MINOR. THE GREAT THING ABOUT PERCENTAGES. IT'S AN EQUALIZER IN HOW YOU LOOK AT THIS.A 2% INCREASE IN THE TAX IS WHAT WE DO BECAUSE 2% SOUNDS MANAGEABLE.BUT THEN JUST BECAUSE SOMETHING'S LESS DOESN'T MEAN THAT 13%'S ANY DIFFERENT.SO I DO FEEL THAT THIS SETS US FORWARD FOR THIS YEAR AND HOPEFULLY NEXT IN SOMETHING THAT'S CONSISTENT, IT'S WHAT RESIDENTS ARE EXPECTING WHILE STILL INVESTING IN INFRASTRUCTURE. THE NEXT STEPS PART OF THIS IS UNDERSTANDING WHAT THOSE INFRASTRUCTURE NEEDS ARE.BEING ABLE TO --RESIDENTS AREN'T CONCERNED ABOUT SPENDING FOR SOMETHING THEY KNOW WHAT THEY'RE GETTING.IT'S A MATTER OF UNDERSTANDING WHERE YOUR MONEY'S GOING.YOU KNOW, WE JOKED AROUND THE OTHER DAY, THAT THE INCREASED TAXES BY 5%, YOU KNOW, GO NUTS AS LONG AS YOU'RE PUTTING ALL 5% INTO ROADS.SPECIFICALLY ROADS IN MY WARDS.BUT ANYWAYS, THE KEY THING IS KNOWING WHERE YOUR MONEY'S GOING, KNOWING WHAT THE NEEDS ARE.WE DIDN'T HAVE THE TIME FOR THAT IN THIS REPORT, AND THAT'S WHAT THIS MOTION DOES.IT GIVES US THE ABILITY TO LOOK AT OUR WATER ASSETS, TO LOOK AT OUR SEWER ASSETS, TO LOOK AT OUR STORM WATER ASSETS CITY-WIDE, WHETHER YOU LIVE ON BRONSON AVENUE, WHETHER YOU LIVE IN GILETTA IT DOESN'T MATTER. THERE'S A NEED ACROSS THE CITY AND WE NEED TO UNDERSTAND THAT SO WE CAN DISCUSS AMONGST OURSELVES AND WITH RESIDENTS WHAT THOSE NEEDS ARE, WHY THE MONEY'S BEING SPENT AND WHY IT MATTERS.WITHOUT THOSE DETAILS IT MAKES IT INCREDIBLY DIFFICULT FOR US TO MAKE THOSE DECISIONS ON BEHALF OF OUR RESIDENTS.SO THANK YOU, COUNCILLOR CHEMUSHENKO FOR MOVING THIS MOTION.I'M HAPPY TO SUPPORT IT BECAUSE IT GETS US DOWN A PATH I FEEL IS MORE CONSISTENT WITH WHAT OUR RESIDENTS ARE EXPECTING AND WHAT WE DISCUSSED WITH THEM NOT MORE THAN A YEAR AGO WHEN WE

APPROVED THE NEW STORMWATER RATE STRUCTURE.THANK YOU.>> ALL RIGHT. THANK YOU, COUNCILLOR MOFFATT FOR YOUR WORK ON THIS AS WELL, AS CHAIR OF ARAC AND COUNCILLOR EL-CHANTIRY.>> ACTUALLY, MR. MAYOR, I WAS GOING TO THANK COUNCILLOR CHEMUSHENKO AND MOFFATT FOR ALL OF US WORKING TOGETHER TO ACHIEVE THAT NUMBER.MR. MAYOR, I DON'T HAVE TO REMIND, A LOT OF MY COLLEAGUES, THE WORK STILL NEEDS TO BE DONE RIGHT ACROSS THE CITY ON OUR INFRASTRUCTURE, BUT WE WERE PLEASED TO SEE THE INCREASE IN SPENDING IN THAT AREA, EVEN IF IT MEANS WE'RE GOING TO CREATE A LITTLE BIT OF DEBT, BUT AFTER WHAT WE SAW THIS SPRING, AND I THINK IT'S OPENED OUR EYES ON THE WORK WE NEED TO BE DONE TO AVOID -- I DON'T BELIEVE THE FLOOD THAT TOOK PLACE HAS ANYTHING TO DO WITH OUR INFRASTRUCTURE, BUT NEVERTHELESS, WE NEED TO IMPROVE OUR INFRASTRUCTURE IN THOSE AREA AND THIS WILL GET US WHAT WE NEED TO DO.AND I KNOW OUR RESIDENTS CAUTION US ABOUT THIS.IF YOU KNOW, IT'S GOING TO START INCREASING, BUT NEVERTHELESS THE LIST OF DEMANDS AND WORK HAS NOT SLOWED DOWN YET, SO ON ONE HAND WE NEED MORE TO BE DONE, ON THE OTHER HAND WE DON'T WANT TO PAY FOR IT.SO IT SEEMS, IT'S A CHALLENGE ALL THE TIME, BUT JUST TO BRING THE PERCENTAGE FROM WHAT IT WAS TO 5%, WHICH WAS WE ALL VOTED FOR EARLIER IN THE YEAR TO MAINTAIN THAT LEVEL OF SERVICE, I THINK WE NEED TO MOVE FORWARD ON THIS.BUT AGAIN, I JUST WANT TO SAY THANK YOU TO BOTH MY COLLEAGUE AND YOUR OFFICE, MR. MAYOR, AND STAFF, AND I'M STILL LOOKING FORWARD TO WHEN YOU DON'T HAVE TO JUST HIGHLIGHT IT IN THIS MEETING, THE INCREASE IN SPENDING.I THINK THAT SHOULD BE A COMMUNICATION OUT THERE WITH THE LIST OF PROJECTS, WHERE THIS MONEY IS GOING TO BE SPENT TO SHOW WHERE VALUE FOR MONEY IS.THANK YOU, MR. MAYOR.>> THANK YOU, COUNCILLOR.COUNCILLOR NUSSBAUM.>> THANK YOU, MR. MAYOR, JUST A QUICK QUESTION OF STAFF.I UNDERSTAND THE ISSUE ABOUT HOW BETWEEN LONG RANGE FINANCIAL PLAN IN 2012 AND NOW, A PRETTY SIGNIFICANT CHANGE WAS MADE IN TERMS OF HOW WE ARE SEPARATING OUT THESE THREE AREAS, AND I HAVE A FAIR BIT OF SYMPATHY FOR THE FACT THAT A 13% INCREASE ALL OF A SUDDEN SEEMS JARRING.ONE THING I WONDERED IS WAS THERE ANY CONSIDERATION GIVEN IN LOOKING AT WAYS OF DEALING WITH THAT, OF POSTPONING THE SEPARATION OF THE THREE SERVICES SO THAT WE STILL HAD A SINGLE RATE INCREASE FOR 2018. SO THAT IN SOME WAY WE COULD DO THE SAME THING BUT ABSORB THE \$1.9 MILLION THAT WE'RE GOING TO HAVE TO ADD, OR THAT WE'RE GOING TO HAVE TO PAY IN ADDITION IN TERMS MUCH DEBT SERVICING? SO WOULD THERE BE A WAY OF ADDRESSING THE STORMWATER RATE, KEEPING A CONSOLIDATED SINGLE RATE INCREASE FOR 2018, AND THEREFORE NOT HAVING TO SPEND AN ADDITIONAL \$1.9 MILLION OVER THE NEXT 10 YEARS?I'M JUST WONDERING IF THAT OPTION, WHAT IS AVAILABLE TO US?>> PART OF THE PROBLEM WITH KEEPING THEM SEPARATE IS THAT YOU ACTUALLY HAVE A GROUP OF PEOPLE, PRIMARILY IN THE RURAL AREAS,

WHO DON'T GET A WATER BILL.SO WE WOULD STILL HAVE TO PARSE OUT WHAT IS THE INCREASE FOR THEM BECAUSE ALL THEY GET IS A STORM RATE.SO WE WILL BE INTRODUCING THE NEW BILL NEXT YEAR, AND PEOPLE WILL BE ABLE TO SEE WE NEED TO MOVE TO THE FIXED AND TO THE VARIABLE COMPONENT.AND I WAS PLEASED TO SEE THAT MCGILL UNIVERSITY RECOGNIZED OUR EFFORTS THAT AND THAT WE'RE LEADING THE COUNTRY IN TERMS OF WHAT THEY FELT WAS BASICALLY VISIBLE AND FAIR WATER AND USE SEWER FEES.SO UNFORTUNATELY I DON'T THINK THERE'S A WAY FOR US TO DO IT, GIVEN THE REALITY OF WHO ACTUALLY IS PAYING.>> RIGHT.OKAY, THANKS FOR THAT ANSWER.>> GREAT.THANK YOU.TO WRAP UP, THEN, IF YOU COULD READ THE THEREFORE BE IT RESOLVED, COUNCILLOR CHEMUSHENKO, PLEASE?>> THANK YOU VERY MUCH, MR. THEREFORE BE IT RESOLVED STAFF BE DIRECTED TO REVIEW THE LONG-TERM FUNDING STRATEGIES FOR THE RATE SUPPORTED PROGRAMMES AS DESCRIBED IN THIS MOTION TO BE REPORTED BACK TO COMMITTEE AND COUNCIL FOLLOWING THE REPORT ON THE UPDATED INFRASTRUCTURE STRATEGIES, OUTLINED IN THE COMPREHENSIVE ASSET MANAGEMENT PROGRAMME UPDATE, WATER AND SEWER RATE SUPPORTED PROGRAMMES REPORT, AND THAT THIS REPORT BE PRESENTED AS EARLY AS POSSIBLE IN THE NEXT TERM.AND, BE IT FURTHER RESOLVED THAT COUNCIL APPROVE THAT THE DRAFT 2018 RATES SUPPORTED RATING AND CAPITAL BUDGET BE DEVELOPED SUCH THAT AN ADDITIONAL \$3.1 MILLION OF THE PLANNED \$83.2 MILLION CAPITAL INVESTMENT IN STORMWATER SERVICES BE FUNDED FROM DEBT, THAT THE INCREASED SPENDING PLAN FOR 2018 BE SET AT \$82.7 MILLION AND THAT THE PLANNED INCREASE IN THE STORMWATER REVENUE BE SET AT 5% AS THE BASIS TO CALCULATE THE 2018 STORMWATER RATES AS DESCRIBED IN THIS MOTION.AND BE IT FURTHER RESOLVED THAT THEY ON BEHALF OF CITY COUNCIL CONTINUE TO WORK WITH THE FEDERAL AND PROVINCIAL GOVERNMENTS ON ESTABLISHING PREDICTABLE LONG TERM FUNDING PROGRAMME FOR THE RENEWAL OF GENERAL MUNICIPAL INFRASTRUCTURE SUCH AS ROADS, CULVERTS AND BRIDGES.>> ANY OTHER WRAP-UP COMMENTS?>> YES, THANK YOU VERY MUCH.ON ONE HAND THE DEBATE THAT WAS DESCRIBED AS THE ANGST THAT OCCURRED OVER THE LAST WEEK WAS PREDICTABLE.ON THE OTHER HAND, I SUPPOSE, I DID NOT EXPECT IT TO HAPPEN AND THEREFORE WE HAD TO DEAL WITH IT AFTER THE FACT. THERE IS AN UNFORTUNATE REALITY WHICH IS THE FACT OF AMALGAMATION IN A PERIOD IN WHICH CERTAIN CLASSES, PARTICULARLY RURAL, BUT NOT JUST RURAL. OF HOME OWNERS AND RATEPAYERS DID NOT PAY FOR THEIR STORMWATER SERVICES FOR A NUMBER OF YEARS BUT ARE NOW FAIRLY BEING ASSESSED TO PAY FOR THEM.WE'VE GOT SOME -- I DON'T KNOW IF THE RIGHT

ANALOGY IS TEETHING PAINS OR BIRTHING PAINS, WITH BRINGING THIS INTO PRACTICE IN THIS COMING YEAR. THERE WERE EXPECTATIONS ASSOCIATED WITH THAT, AND THE NUMBERS THAT WERE SEEN IN FRONT ON THE REPORT THAT CAME TO COMMITTEE LAST WEEK SEEMED TO GO AGAINST WHAT SOME PEOPLE'S EXPECTATIONS WERE. PLEASE STAND BY 1>> I REALLY HOPE THAT WE ARE GETTING OVER THAT AND THAT WE WILL.STORM WATER SERVICES ARE ESSENTIAL TO ALL OF US, ALTHOUGH THEY ARE OFTEN AS INVISIBLE TO URBAN AS TO RURAL RESIDENTS.THEY ARE TYPICALLY UNDER THE GROUND.WE DON'T LOOK AT THEM.WE DON'T REALLY CARE ABOUT THEM UNTIL THEY FAIL AND WHEN THEY FAIL, WE REALLY, REALLY CARE ABOUT THEM AND WE WISH SOMEBODY HAD DONE SOMETHING ABOUT IT AND SPENT THE MONEY THEY SHOULD HAVE SPENT ON MAINTENANCE BEFORE THEY FAILED.SO THAT'S WHEN IT BECOMES A HUMAN COST AS WELL AS A FINANCIAL COST.>> WE ASKED OUR STAFF TO PROVIDE US A LIST OF MAINTENANCE THAT NEEDS TO BE DONE SO WE PREVENT AS MUCH AS WE CAN.WE PREVENT THOSE SORTS OF THINGS FROM HAPPENING. THEY BROUGHT THAT FORWARD TO US PROFESSIONALLY AND WE NOW VOTING ON A MOTION WHICH HAS REJIGGED A FEW THINGS. RESPONDED TO CONCERNS THAT WE'VE HEARD. SO IT IS AN IMPORTANT FILE FOR ME.I'VE CARRIED THROUGH THE AMENDMENTS TO A BILL 57 PROVINCIALLY AND NOW THEY'VE GIVEN THE AUTHORITY, THE PROVINCE HAS, FOR MUNICIPALITIES TO START REGULATING THE PAYDAY LOANS.AND WE'RE TAKING AN OPPORTUNITY, THERE'S TWO ELEMENTS, ONE WHICH IS A ZONING REVIEW, ONE WHICH IS A LICENSING, SO WE'D LIKE TO BEGIN WITH THE ZONING COMPONENTS OF IT.SO I THINK YOU HAVE THE MOTION IN FRONT OF YOU AND THE RELEVANT PARTS ARE ACTUALLY JUST THEREFORE BE RESOLVED THAT COUNCIL DIRECT STAFF IN PLANNING. INFRASTRUCTURE, AND THE ECONOMIC DEVELOPMENT DEPARTMENT TO ADD TO THEIR 2018 WORK PLAN, THE PREPARATION OF A REPORT RECOMMENDING REGULATIONS FOR PAYDAY LOAN ESTABLISHMENTS FOR CONSIDERATION BY PLANNING COMMITTEE AND CITY COUNCIL.AND MAYBE, MR. MAYOR, I KNOW THERE'S A FEW SPEAKERS ON IT, BUT WE'VE WORKED CLOSELY WITH STEVEN WILLIS ON THE MATTER, SO I WONDER IF -- I MEAN, I'M PRIVY TO THOSE CONVERSATIONS, BUT MR. WILLIS, MAYBE YOU CAN SPEAK TO THE IMPORTANCE OF DOING SUCH AN APPROACH REGARDING THE ZONING, FACTORING THE MATTER THAT CURRENTLY OUR ZONING ENCOMPASSES, ALL OF THE FINANCIAL INSTITUTIONS, SO WE DON'T DIFFERENTIATE BETWEEN A BANK AND A PAYDAY LENDER.>> SO MR. MAYOR, JUST TO CLARIFY, IN THE OMNIBUS AMENDMENTS NOTWITHSTANDING THE MOTION, WE TOOK THE OPPORTUNITY, AS WE DO ON AN ANNUAL BASIS, TOOK THE OPPORTUNITY BECAUSE OF BILL 57 TO DISTINGUISH IN THE ZONING BYLAW BETWEEN A PAYDAY LOAN ESTABLISHMENT AND A FINANCIAL INSTITUTION, BUT FOR ZONING PURPOSES FROM THIS DAY FORWARD, THEY'RE NOT THE SAME THING AND THAT'S WHAT BILL 57 PROVINCIALLY ALLOWS US TO DO.AT THIS STAGE, IT DOES NOTHING ELSE THAN THAT.WHERE BANKS ARE PERMITTED, WHERE FINANCIAL SITUATIONS ARE

PERMITTED TODAY, PAYDAY LOANS TODAY WILL ALSO BE PERMITTED AS A RESULT OF THIS CHANGE BECAUSE WE'VE NOT YET DONE THE WORK TO DEVELOP PERFORMANCE STANDARDS FOR THEM FROM A LAND USE PERSPECTIVE, SO WHAT THE MOTION DOES IS IT TAKES US TO THE NEXT STAGE FROM THE LAND USE PERSPECTIVE AND WE'LL SPEND THE NEXT YEAR DEVELOPING PERFORMANCE STANDARDS FOR THEM AS IT RELATES TO THE LAND USE QUESTION.AND WE NEED TIME TO DEVELOP, BECAUSE IT'S A NEW LAW, NEW LEGISLATION, WE NEED TO DEVELOP A COHERENT CASE AND COMPARE BEST PRACTICES WITH OTHER MUNICIPALITIES OF ONTARIO AND MAKE A CASE THAT WE CAN DEFEND IF REQUIRED.
