REPORT RECOMMENDATION

That the Ottawa Public Library Board approve the creation of five Ad Hoc Committees with composition as identified in this report.

RECOMMANDATION DU RAPPORT

Que le Conseil d'administration de la Bibliothèque publique d'Ottawa approuve la création de cinq comités spéciaux dont la composition est décrit dans le rapport.

BACKGROUND

In accordance with the Ottawa Public Library (OPL) Board Rules of Procedure By-Law Section 42(2) "The Board may establish ad hoc committees of limited duration, to advise, inquire, and report on a particular matter or concern. An ad hoc committee shall report on their work to the Board as required under the scope of work established through Terms of Reference, and such other provisions as the Board shall deem proper. Ad hoc committees dissolve automatically upon the submission of a report to the Board on the work of the matter or concern."

Except for the CEO performance committee, each ad-hoc committee is comprised of a combination of staff (minimum of three; maximum of five) and two trustees. The Chair of the Board sits ex-officio on all ad-hoc committees.

The CEO Performance committee consists of the Chair, Vice Chair, and one additional trustee, plus the CEO. This committee is established for the duration of the term of the Board for CEO Performance oversight.

This report provides the Board with recommendations on the creation and composition of five ad hoc committees required at this time.

DISCUSSION

Typically, requests for creation and participation are brought to the Board on an ad hoc basis as part of a report or matter before the Board. As part of the constitution of the 2019 – 2022 term of the OPL Board, five ad hoc committees are requested at this time to advise staff on matters that were initiated under the previous Board and outstanding, or new committees anticipated to be required in the coming months.

OPL requires the following committees to advise staff on matters initiated under the previous Board, which require support through to completion within 12 months:

- Hours of Operation (two trustees)
- Intellectual Freedom (two trustees)

OPL requires the following new ad hoc committees to be established to advise staff within the defined mandates as noted below:

- Fundraising (two trustees) to support the development of the Fundraising
 Strategy, prospect identification and qualification, and participate in cultivation
 activities. This includes reviewing OPL Board Policy #008 Donations,
 Fundraising, Sponsorships, and Advertising to ensure alignment with the
 Fundraising Strategy. This ad hoc committee is expected to be required for an
 anticipated period of 18 months. It should be noted that the establishment of this
 committee is subject to Board and Council approval of the required resources to
 initiate work on the fundraising strategy.
- Alternative Services (two trustees) to advise staff on the implementation plan associated with the Alternative Services priorities approved by the Board in November 2018 and public engagement plan regarding proposed changes to

bookmobile stops. This ad hoc committee is required for an anticipated period of 12 months.

In preparing the recommendations, staff sought expressions of interest from Trustees. In addition, staff considered the mix of citizen and councillor trustees on each committee, as well as participation of each trustee on a minimum of one ad hoc committee.

Staff recommend that the Board approve participation on the ad hoc committees as follows:

- Alternative Services Trustee Brown and Vice Chair Fisher
- CEO Performance Chair Tierney, Vice Chair Fisher, and Trustee Begg
- Fundraising Trustees Brockington and Slack
- Hours of Operation Trustees Higdon and Luloff
- Intellectual Freedom Trustees Begg and Meehan

CONSULTATION

As part of the consultation process, trustees were provided with details of the required ad hoc committees and encouraged to express interest by February 5, 2019.
