Ursula K. Melinz, Soloway Wright LLP, for the Salvation Army (written submission)

- noted the Salvation Army is currently a party to an appeal that was heard by the Local Planning Appeal Tribunal in August 2018 regarding the use of 102 Bill Leathern Drive as a place of worship; requested that this staff report and its proposed changes not be applied to 102 Bill Leathern in the event the Tribunal grants development approval as requested
 - noted several of the changes proposed in the Urban Employment Report, if applicable at 102 Bill Leathern, will require additional development approvals from the City, and suggested it is not appropriate to impose new criteria in light of the long development history associated with 102 Bill Leathern (the development applications for 102 Bill Leathern were submitted by the Salvation Army's consultants in 2016, and since then, the Salvation Army has pursued development approval without delay; the current delay is all parties are waiting for the Tribunal to issues its decision for the August 2018 hearing)
