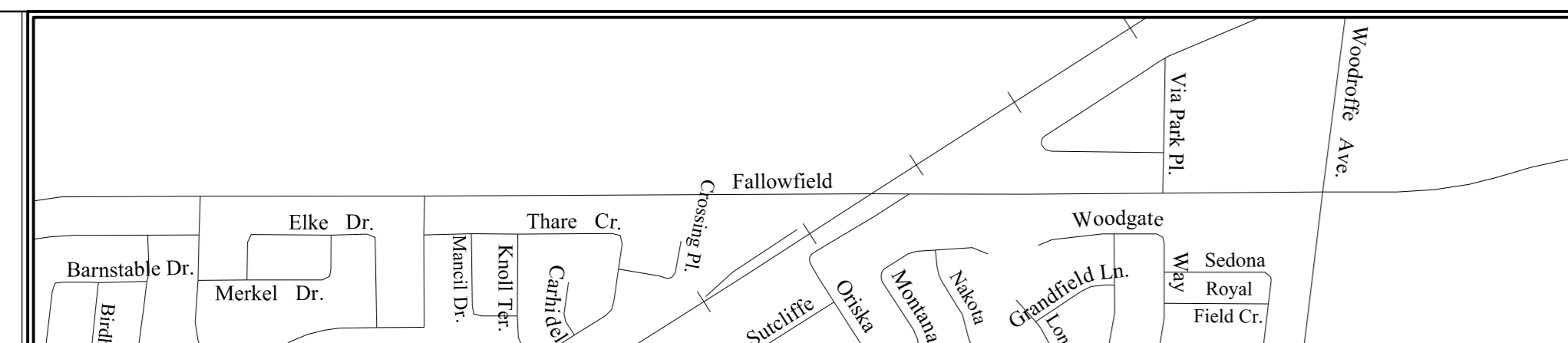

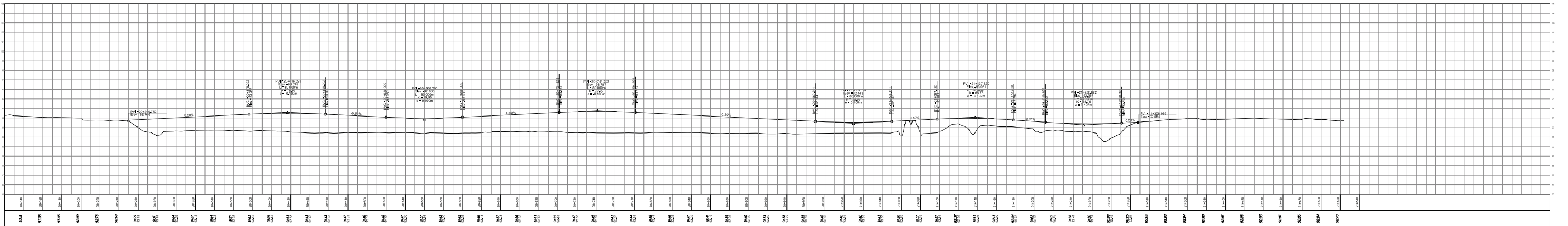


FALLOWFIELD ROAD REALIGNMENT
