

**8. REQUEST TO EXTEND HOURS FOR 283 ELGIN STREET AND FOR ALL  
RIGHT OF WAY PATIOS FOR CANADA DAY 2017 CELEBRATIONS -  
MOTION**

**COMMITTEE RECOMMENDATION**

That City Council:

1. Waive the condition that the patio at 283 Elgin Street be required to close by 11 p.m. on June 30, July 1 and July 2, 2017 and extend their patio closing time to 2 a.m.; and
2. Delegate the authority to the General Manager of Planning, Infrastructure and Economic Development, in consultation with the Director of 2017 Operations and Special Events and the local ward Councillor, to temporarily extend the hours for ROW patio permit holders who request permission to extend closure from 11 p.m. to up to 4 a.m. on June 30, July 1 and July 2, 2017, and that such authorization may be subject to terms and conditions imposed by the General Manager of Planning, Infrastructure and Economic Development.

## **REPORT RECOMMENDATIONS**

That the Transportation Committee recommend that City Council:

1. Waive the condition that the patio at 283 Elgin Street be required to close

by 11 p.m. on June 30, July 1 and July 2, 2017 and extend their patio closing time to 2 a.m.; and

2. Delegate the authority to the General Manager of Planning, Infrastructure and Economic Development, in consultation with the Director of 2017 Operations and Special Events and the local ward Councillor, to temporarily extend the hours for ROW patio permit holders who request permission to extend closure from 11 p.m. to up to 4 a.m. on June 30, July 1 and July 2, 2017, and that such authorization may be subject to terms and conditions imposed by the General Manager of Planning, Infrastructure and Economic Development.

## BACKGROUND

The Transportation Committee at its meeting of 7 June 2017, approved the following motion, which was added to the agenda pursuant to subsection 89(3) of the Procedure By-law (By-law 2016-377):

*WHEREAS, on April 27, 2011, in considering report [ACS2011-ICS-PGM-0078](#), Council approved waiver of the residential encroachment provisions to allow for an outdoor patio*

*at 283 Elgin Street, on the condition that the patio, when in operation, would be required to close each night by 11 p.m., and that no patrons be permitted in the area after this time; and*

*WHEREAS the City of Ottawa Right of Way (ROW) Patio By-law (No. 2017-92), Section 7(2), provides that any conditions or requirements related to noise or noise attenuation imposed on a pre-existing front, curbside or streetside patio in a permit granted by the City prior to the coming into force of this by-law (April 12, 2017) shall continue and be imposed on any permit issued under this by-law for such a patio; and*

*WHEREAS the City has received a request to waive the condition that the outdoor patio at 283 Elgin Street be required to close by 11 p.m. on June 30, July 1 and July 2, 2017 and extend their patio closing time to 2 a.m.; and*

*WHEREAS the City of Ottawa Right-of-Way (ROW) Patio By-law (No. 2017-92), Section 7(3) also provides that the ROW patio within 30 metres of any property zones as residential or mixed residential/commercial is required to close each night by 11 p.m., and that no patrons be permitted in the area after this time; and*

*WHEREAS the City is celebrating Canada's sesquicentennial on July 1, 2017, and wishes to delegate the authority to the General Manager of Planning, Infrastructure and Economic Development, in consultation with the Director of 2017 Operations and Special Events and the local ward Councillor, to temporarily extend the hours for all ROW patio permit holders upon their request;*

*THEREFORE BE IT RESOLVED that Transportation Committee recommend that City Council waive the condition that the patio at 283 Elgin Street be required to close by 11 p.m. on June 30, July 1 and July 2, 2017 and extend their patio closing time to 2 a.m.; and*

*THEREFORE BE IT FURTHER RESOLVED that Transportation Committee recommend that City Council delegate the authority to the General Manager of Planning, Infrastructure and Economic Development, in consultation with the Director of 2017 Operations and Special Events and the local ward Councillor, to temporarily extend the hours for ROW patio permit holders who request permission to extend closure from 11 p.m. to up to 4 a.m. on June 30, July 1 and July 2, 2017, and that such authorization may be subject to terms and conditions imposed by the General Manager*

*of Planning, Infrastructure and Economic Development.*

### **DISCUSSION**

The Committee unanimously supported the aforementioned motion and agreed that it would be presented to Council on 14 June 2017.
