BACKGROUND

Ottawa Public Health's (OPH) Strategic Plan sets out a roadmap and vision for the organization for the next four years and provides a framework to guide future decision-making. The Strategic Plan addresses the key public health challenges we face in Ottawa. It identifies a series of strategic directions to advance health for the people who live, learn, work and play in our communities.

In December 2013, OPH began a planning process for the 2015-2018 Strategic Plan which culminated in Building a Healthier Ottawa: Ottawa Public Health 2015-2018 Strategic Plan. A number of inputs informed the development of this plan including local level data (the State of Ottawa's Health 2014 report), a review of the grey literature, as well as over 2,000 survey responses from residents, community partners, and staff.

The Strategic Plan's directions outline the vision, mission, and principles underlying the programs and services offered by OPH. Moreover, it identifies areas to enhance focus and foster innovation in order to respond to community health issues, and continually improve and create the conditions in which people can live healthy lives.

OPH delivers a range of core programs and services that are required by Provincial legislation. The new strategic directions serve to reinforce OPH's work in the context of meeting Provincial requirements and addressing local needs.

DISCUSSION

OPH's new Strategic Plan, as outlined in Supporting Document 1, is driven by its vision, mission, and five strategic directions. Also included in this Plan are five key principles which lay the foundation for the delivery of all of OPH's programs and services. The interconnection between these principles and OPH's vision and mission are illustrated in OPH's framework, which provides the foundation for how the organization operates and the goals OPH aims to achieve.

Strategic Direction #1 – Inspire and Support Healthy Eating and Active Living

Strategic Direction #2 - Foster Mental Health in Our Community

Strategic Direction #3 - Enhance Collective Capacity to Reduce Preventable Infectious Diseases

Strategic Direction #4 - Develop an Adaptive Workforce for the Future

Strategic Direction #5 – Advance Healthy Public Policy

NEXT STEPS

OPH will share this strategic plan with community partners, and it will develop initiatives to support its implementation. This includes engaging with staff and partners to identify alignments with existing programs and services, as well as develop new and innovative approaches to address the health needs of our community. In addition, mechanisms for ongoing monitoring of the execution of the Strategic Plan will be developed.

The Ottawa Public Health Strategic Plan was informed by input from staff, community partners, residents, City of Ottawa partners, and the Board of Health.
