At the outset, the Chair noted staff had requested that Committee approve a technical revision to the report to reflect an increase in the outstanding commitments for Public Transit to \$65,522,252 from \$18,133,852. Ms. Marian Simulik, City Treasurer, explained that this would serve to adjust the Unapplied Capital Project Funding and Debt Requirements for this service category, to more accurately reflect current and future obligations in relation to transit-related capital projects that will require development charge funding.
