**SUBJECT: Ottawa Community Housing Corporation (OCHC) Confirmation of Re-Election of Chair, Appointment of Directors, Repeal of By-Law No. 9, and Approval of By-Law No. 10**

## REPORT RECOMMENDATIONS

1. That the re-election of Councillor Fleury to the position of Chair of Ottawa Community Housing Corporation (OCHC) for the year 2017 be confirmed by the Shareholder (Document 1); and
2. That the appointments of Mr. Ben Sorensen and Ms. Ferenaz Raheem to the OCHC Board of Directors as Community Members for terms of three (3) years as described in this report and set out in Document 2 be approved;
3. That the OCHC By-Law No. 9 be repealed and be replaced by a new By-Law No. 10 incorporating changes to clarify roles, align with legislation and reflect best practice as described in this report and set out in Documents 4 and 5;
4. That the Mayor and the City Clerk be authorized to sign a written resolution on behalf of the City of Ottawa as Shareholder of OCHC setting out the resolutions approved by City Council.

## **EXECUTIVE SUMMARY**

This report provides information to support the 2017 OCHC re-election of the Board Chair, the appointment of two OCHC Board Directors, the repeal of OCHC By-Law No. 9 and the approval of OCHC By-Law No. 10.

## **BACKGROUND**

At its meeting on January 19, 2017, OCHC's Board of Directors approved the recommendations set out above.

## **DISCUSSION**

### **Recommendation 1:**

Since 2015, Councillor Fleury has held the position of Chair of OCHC, confirmed by the Shareholder. Prior to his position as Chair, he held a position as Board member for OCHC since 2010, and was actively involved as both a Board and Board committee member. Councillor Fleury was re-elected Chair of the OCHC Board on January 19, 2017. (Document 1);

### **Recommendation 2:**

Mr. Ben Sorensen has been a member of OCHC's Finance and Audit Committee and Governance Sub-Committee and Ms. Ferenaz Raheem has been a member of OCHC's Corporate Affairs Committee since January 2015. The OCHC Board recommends that Mr. Sorensen and Ms. Raheem be appointed to the OCHC Board of Directors as Community members for a term of three (3) years, (Document 2); and

### **Recommendation 3:**

The proposed amendments to OCHC's current operating By-law No. 9 as set out in Report OCHC-002/17 were approved by OCHC's Board of Directors at its meeting on January 19, 2017. (See excerpt of the minutes of the January 19, 2017 OCHC Board of Directors meeting as set out in Document 3, and Document 4 – By-Law Proposed Changes Table which describes the proposed changes, as well as the revised By-Law

No. 10.(Document 5). By-Law No. 10 legally becomes effective when approved by the Shareholder.

**Recommendation 4:** That the Mayor and the City Clerk be authorized to sign a written resolution on behalf of the City of Ottawa as Shareholder of OCHC setting out the resolutions approved by City Council.
