BACKGROUND

Attendance and active participation at Board meetings is a fundamental obligation of a Board member. This obligation arises under the Board's legal duty to supervise the management of the business and affairs of the Ottawa Public Library.

DISCUSSION

Attendance at meetings is recorded by the Library Board Assistant, confirmed in the meeting minutes, and verified by all trustees prior to the official release of the attendance report. An email was forwarded to all trustees on December 12, 2013 requesting their review of their individual record of attendance.

Table 1 as presented in Appendix 1, sets forth the number of regular and special meetings of the Board held between January 1, 2013 and December 31, 2013 and the record of attendance at these meetings of all Board trustees throughout the year.

CONSULTATION

Board input was sought in the development of this report. Trustees were asked to review and confirm their attendance record for the year in question.

LEGAL IMPLICATIONS

The requirement to record trustee attendance is defined by the Board's By-laws, Section 5.3. Through the Board By-law review process, it has been identified that the current OPL Board By-laws do not comply with section 13 (c) of the *Public Libraries Act, R.S.O. 1990, Chapter P.44*. The section states: "If a Board member is absent from the meetings of the board for three consecutive months without being authorized by a board resolution, the member's seat becomes vacant and the remaining members shall forthwith declare the seat vacant and notify the appointing council accordingly." This does not align with section 5.1 of the Board's current by-laws which states: "If a member is absent for two consecutive months of regular meetings without the board member providing written explanation for his/her absence, the member shall be notified by the Secretary that a third absence may result in the member's seat being declared vacant by the Board." As part of the revision of the Board's Procedural By-laws, language will be clarified in the area of trustee absences so as to ensure full compliance with the Public Libraries Act.
