Document 2: Draft Personal Services Settings Online Survey

<u>Let us know what you think about a new registration system for Personal Service Settings</u>
(e.g. hairdressers, barbershops, tattoo studios, and aesthetic service businesses)

Ottawa Public Health (OPH) is suggesting changes to how Personal Service Settings (PSS) operate that might affect you and we are looking for your feedback. Your participation in this survey is voluntary and all answers will remain anonymous and confidential. We are not tracking or collecting Internet Protocol (IP) address information. Refusing to take part in the survey or the answers you give if you do take part will not change any service or support you get from Ottawa Public Health. The survey should take approximately 5-10 minutes to complete.

OPH is proposing a new "Personal Service Settings (PSS) Registration" by-law for the City of Ottawa that would:

- Require that all Personal Services Settings, such as hairdressers, barbershops, tattoo and body piercing studios, providers of electrolysis and other aesthetic services register their business with OPH at no cost;
- Allow registration to be completed online, in person, by phone or by mail;
- Recognize businesses that uphold good practices; and
- Create reasonable financial penalties that could be applied for repeated failures to use good infection prevention and control practices, according to the seriousness of the risk to health created.

Background

OPH works to protect the public by reducing the spread of infectious diseases in the City of Ottawa. Businesses that offer "Personal Services", such as hairdressers, barbershops, premises that offer manicures and pedicures, tattoo, micropigmentation and body piercing studios, providers of electrolysis and other aesthetic services typically provide safe services, but the spread of infections can occur when proper health practices are not followed.

OPH is proposing changes that will create a level playing field for all PSS owners and operators. Requiring all PSS owners and operators to register their business with OPH, at no cost, will allow OPH to know the location of all PSS in the city. As PSS do not require a business license from the City of Ottawa, there is currently no way for OPH to be confident and assure it has identified all the PSS in Ottawa.

Creating financial penalties, which are approved by the chief justice of the Ontario court of justice, allows OPH to address the businesses that repeatedly fail to uphold the required proper health practices. This change will allow OPH to issue fines or "tickets" to businesses to encourage improvement of their services.

The premises and all its items (e.g. furniture)
must be kept in good repair and in a clean and
sanitary condition.

Every table, mat or other surface upon which

Service shall have a smooth top surface of
impervious material.
The location must have a sink with an adequate
supply of hot and cold water, which, when used
for cleaning of instruments and equipment, and
must be a type and size adequate for the proper
cleaning of such instruments and equipment and
which, when used for hand cleaning, shall have:
a. An adequate supply of liquid soap in a
suitable container or dispenser;
b. Hot air dryers or individual clean towels
for hand drying; and
c. A suitable receptacle for used towels and
waste material.
All personal service workers must clean their
hands both before and after providing a service.
All instruments and equipment used which are
not single-use items must be properly cleaned

and disinfected, or cleaned and sterilized,		
between each use.		
Instruments and equipment that have been		
cleaned and disinfected or sterilized will be		
stored and handled in a manner that prevents		
contamination.		
All sharp instruments must be disposed of in an		
approved sharps container and the container		
must be disposed of as pathological or		
biomedical waste.		
Single use instruments/equipment must be used		
on one person only and must be disposed of		
immediately upon use.		
Mechanical sterilizers must be monitored on a		
regular basis by spore testing and by the use of		
temperature sensitive indicators.
